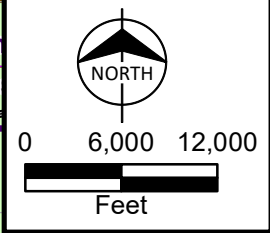
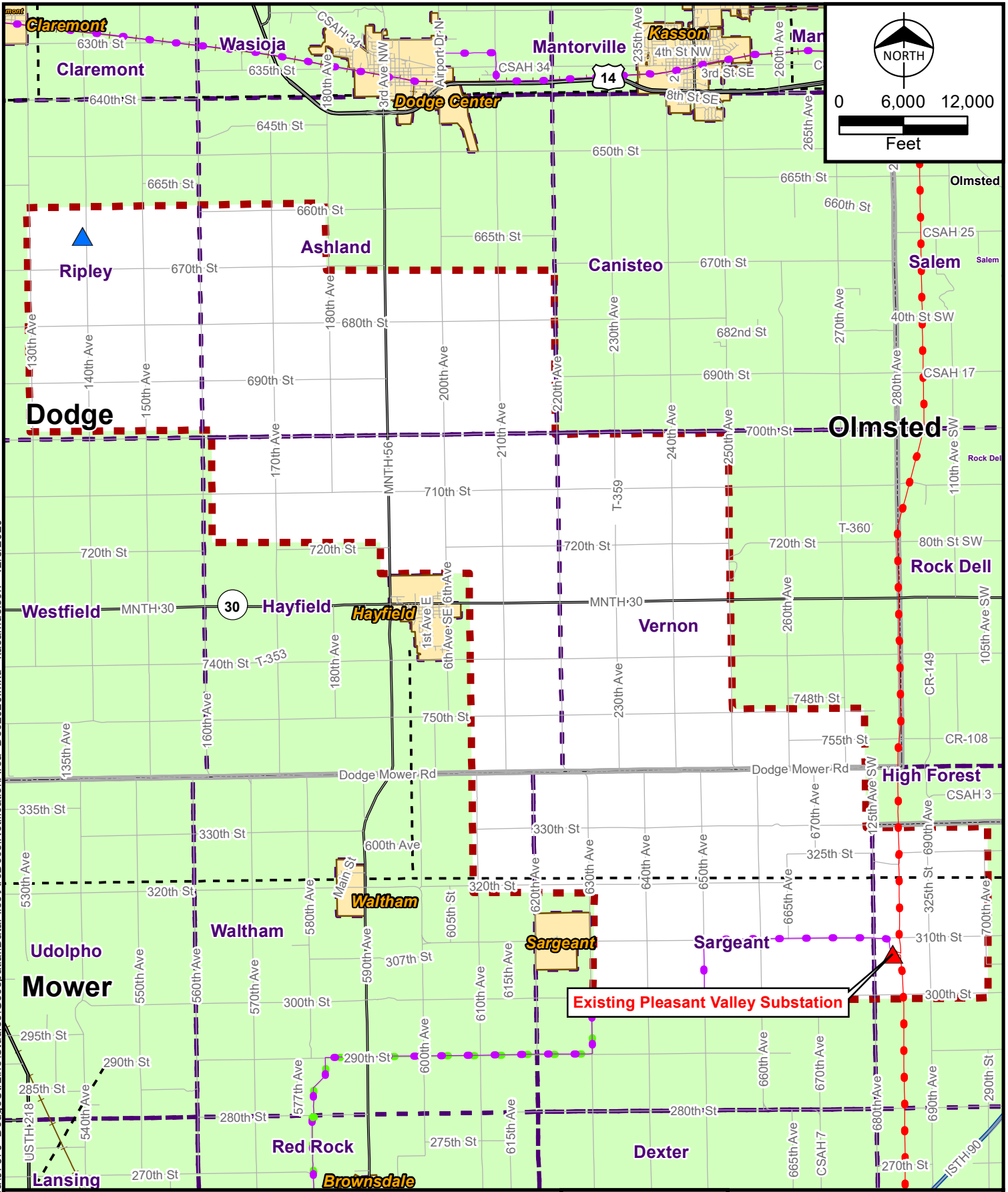

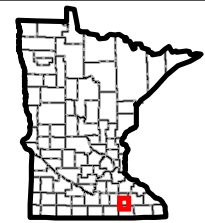


**Figure 1 - Proposed Transmission Route Map**

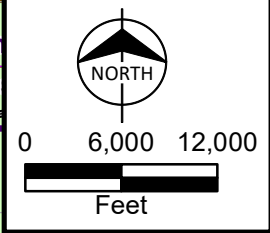
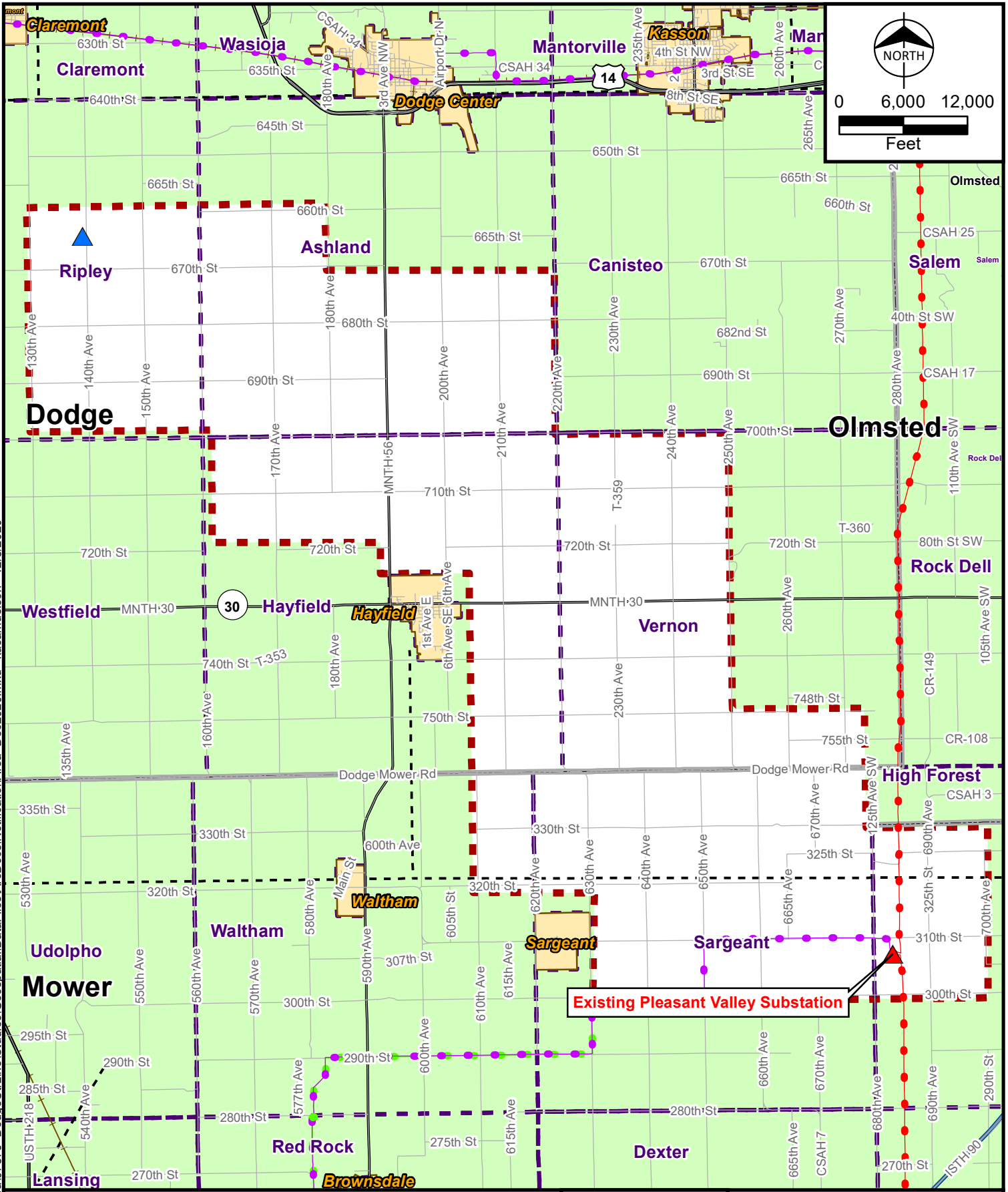
