SUMMARY OF CERTIFICATE OF NEED FILING

On May 9, 2025, Northern States Power Company, doing business as Xcel Energy (Company or Xcel Energy), filed an application with the Minnesota Public Utilities Commission (Commission) seeking a certificate of need for two combustion turbines and associated facilities that are part of the proposed Lyon County Generating Station project (Project) in Lyon County in Minnesota. The two combustion turbines together will provide approximately 420 megawatts (MW) of capacity. Associated facilities include two short 345 kilovolt transmission lines, onsite operation facilities, and three 750-kilowatt emergency diesel generators to provide emergency power. The transmission lines will connect the Project to the Minnesota Energy Connection (MNEC) Garvin Substation. The combustion turbines will receive fuel through a natural gas pipeline extension to connect the Project to an existing Northern Border pipeline. The proposed facilities will be located entirely on property that will be owned by Xcel Energy in Lyon County adjacent to the Garvin Substation.

The Project is needed to provide replacement firm dispatchable resources to continue to reliably serve customers after the retirement of Xcel Energy's remaining coal-fired units at the Sherburne County Generation Station. The Project will also provide stability support to MNEC, which will facilitate thousands of megawatts of new renewable generation on Xcel Energy's system. Xcel Energy plans to place the Project in-service in December 2028.
