**REPLY COMMENTS ON
NOTICE PLAN PROPOSAL**

Minnesota Pipe Line Company, LLC (“MPL” or “Company”) submits these Reply Comments to the May 6, 2014 Comments of the Minnesota Department of Commerce, Division of Energy Resources (“Department”) related to MPL’s April 17, 2014 Notice Plan filing with the Minnesota Public Utilities Commission (“Commission”) in the above-captioned docket. The Department recommended that the Commission accept MPL’s proposed Notice Plan filing, subject to the provision of additional information, clarifications or corrections. MPL appreciates the Department’s thorough review of the Notice Plan filing and will address each of the Department’s recommendations, in turn. As discussed below, MPL agrees with the Department’s recommendations, and in these Reply Comments provides additional information, clarifications and certain corrections, as appropriate.¹

¹ MPL has reviewed each of the potential corrections identified by the Department regarding the local officials list and agrees that many of those corrections are proper. For

- 1. Describe how MPL has or will identify the names and addresses of the landowners and residents to receive direct mail notice under Minn. R. 7829.2560, subps. 3 A and B.**

The landowners receiving direct mail notice under Minn. R. 7829.2560, subps. 3 A and B have been identified by reviewing local property records in each of the counties through which Line 4 runs.

- 2. Confirm that MPL will provide notice to all landowners and residents that own or live on the land abutting the land on which the pump stations will be constructed or upgraded.**

MPL confirms that it will provide the direct mail notice included with these Reply Comments as Revised Exhibit C to all landowners and residents that own or live on the land abutting the land on which the pump stations will be constructed or upgraded.

- 3. Clarify, and if necessary correct the discrepancies in Notice Plan Exhibit E and the Supplement as identified by the Department at pages 2-4 of its Comments.**

MPL has thoroughly reviewed and rechecked the information provided in its original Exhibit E and in its supplemental filing listing township officials and the possible corrections to those lists identified by the Department. MPL agrees that several corrections appear appropriate. Attached as Revised Exhibit E is a corrected list, merging and correcting, as appropriate, the information originally provided in both Exhibit E and the supplement listing township officials. Also attached as Exhibit E-1 is a listing which highlights the information which has been revised from the original filings.

some of the potential corrections, after verification of the contacts, MPL continues to believe the initial Notice Plan filing identified the appropriate persons.

- 4. Clarify how the map required by Minn. R. 7829.2560, subp. 4 will be included in the notice letters sent to landowners, residents and government officials.**

MPL will include the map as an attachment to the notice letters.

- 5. Submit revised notice letters to landowners, abutting residents, and local and state government officials in which the additional information requested by the Department regarding the pumping station sites and their locations is presented in the tabular form described in the Department Comments.**

MPL will include the requested information and provides Revised Exhibits B, C and D incorporating that information. In addition, MPL provides a Revised Exhibit A overview map and new maps of each pumping station location, identified as Exhibits A-1 through A-8.

Having addressed each of the Department's recommendations, MPL respectfully requests that the Commission approve the Notice Plan as supplemented, clarified and corrected by these Reply Comments.

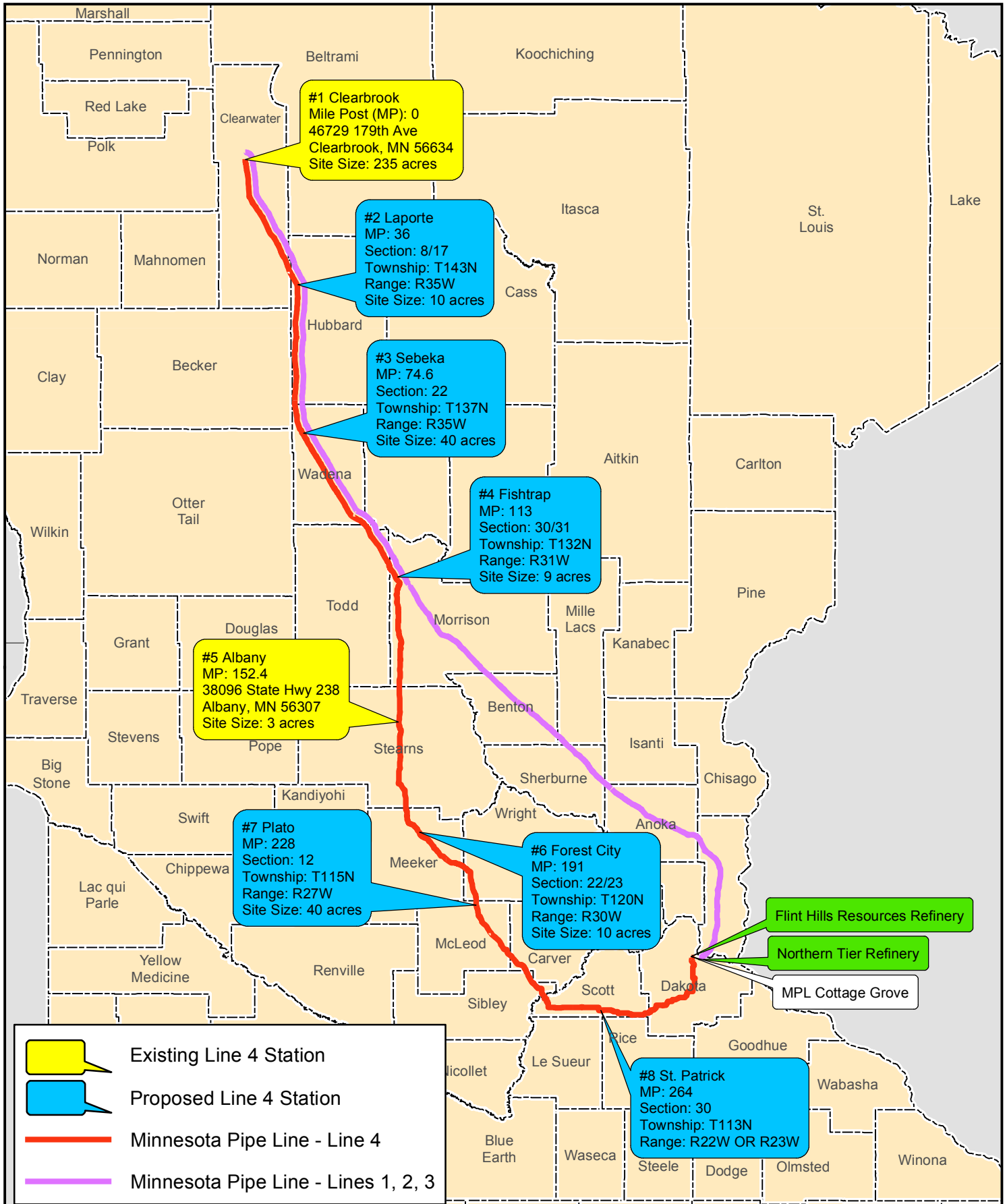

Minnesota Pipe Line System

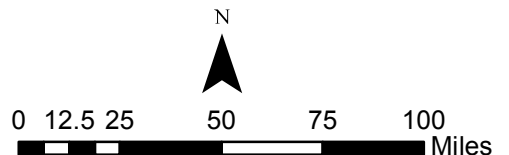
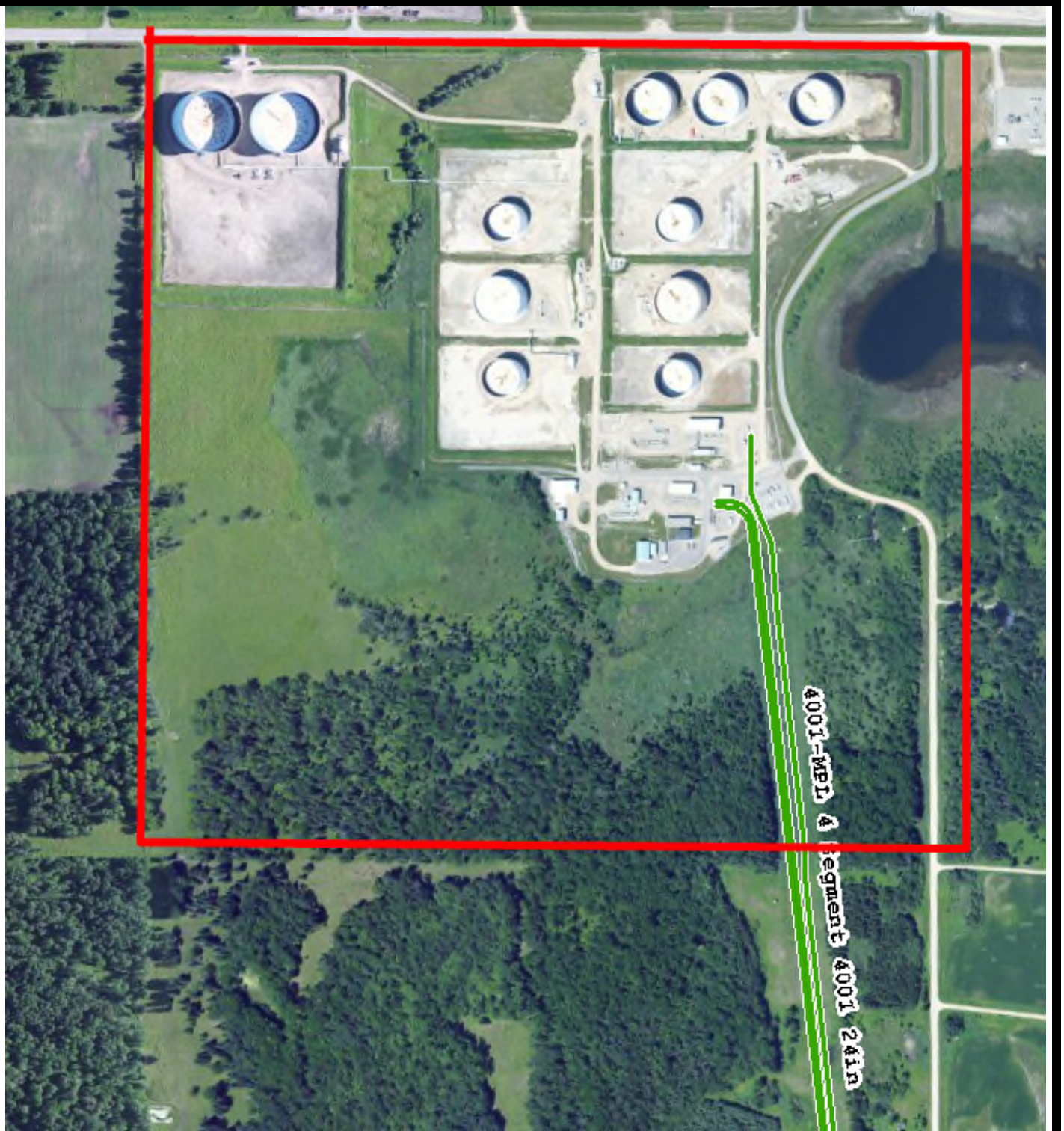

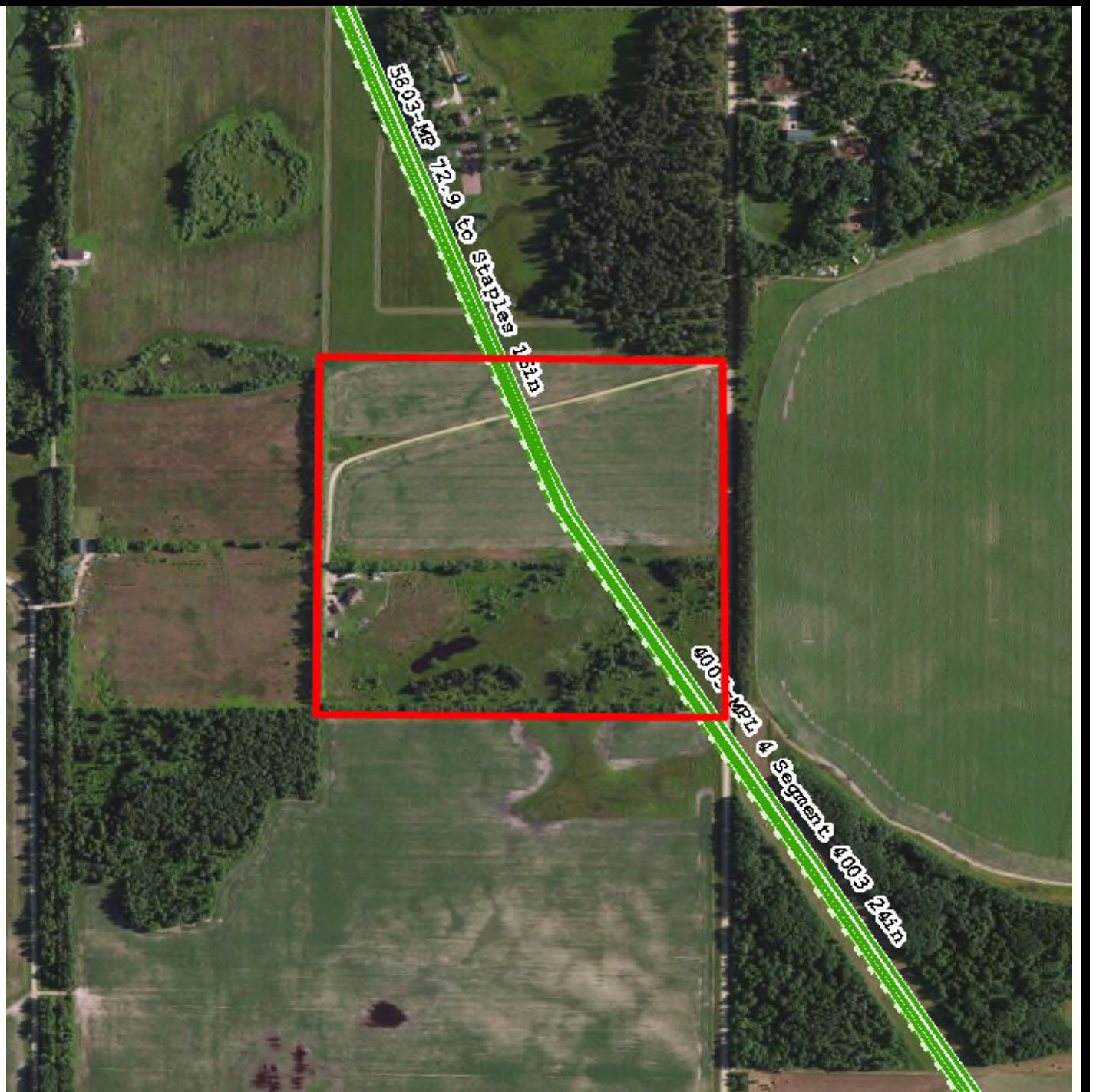
