In the Matter of the Request of Preferred Long Distance Inc. to Add Telplex Communications and Telplex to its Certificate of Authority, as Assumed Names. (PUC: Oberlander; DOC: Johnson) NOTE: Staff supports the Department's recommendations regarding the proposed name change and nomadic VoIP service.

In the Matter of the Petition of Minnesota Energy Resources
Corporation (MERC) for Approval of a Tariff Revision and a New Area
Surcharge for the Ely Lake Project Petition to Modify Previously

Should the Commission approve Minnesota Energy Resources Corporation's (MERC's) request to modify its Ely Lake New Area Surcharge (NAS) factors? (PUC: **Brill**)

Approved NAS factors and tariff language; required customer disclosures; required compliance filing.

Xcel Energy

In the Matter of a Petition by Northern States Power Company (Xcel) for Approval of Changes in Contract Demand Entitlements for the 2014-2015 Heating Season Supply Plan effective November 1, 2014.

Should the Commission approve Northern States Power Company (Xcel) proposed demand entitlement capacity (levels) and cost changes to meet its Design Day and Reserve Margin requirements as

described in the listed docket, effective November 1, 2014? (PUC: **Brill**)

Approved demand entitlements as amended; allowed recovery of demand costs through PGA; required compliance info; and required storage entitlements, by contract, in future petitions.

In the Matter of Xcel's Request for an Extension of its Gas Capacity Utilization Accounting Treatment.

Should the Commission approve a permanent extension of the accounting treatment for the natural gas capacity utilization plan for Xcel's gas distribution and electric generation business units? (PUC: **Bender, Brill**)

Approved Capacity Utilization plan as permanent; accepted reporting agreement requirements; and required meeting with PUC staff and DOC.

5. ** E002/GR-13-868 Northern States Power Company d/b/a Xcel Energy

In the Matter of the Application of Northern States Power Company for Authority to Increase Rates for Electric Service in the State of Minnesota.

Should the Commission grant the petition for reconsideration of its August 31, 2015 Order as requested by the Office of the Attorney General?

If so, should the Commission change or modify its decision authorizing Xcel to recover its 2015 revenue deficiency as it accrued beginning on March 3, 2015 and through the date new, final rates are put into effect? (PUC: **Harding**)

The Commission has the authority to accept or decline a petition for reconsideration **with or without** a hearing or oral argument. (Minnesota Rules 7829.3000, Subpart 6) In other words, a decision on a petition for reconsideration can be made without taking oral comments at the Commission meeting.

Reconsideration denied.
