The Department of Commerce (Department) has reviewed the petition and the supplement to the petition of the Fond du Lac Communications, Inc. (FDLCI) to the Federal Communications Commission (FCC), along with the Staff Briefing Papers. The Department concurs with Staff's recommended decision to accept FDLCI's request to provide FDLCI's counsel written confirmation that the Commission defers to the FCC to make the ETC determination.¹

The Department also agrees with Staff's findings that any request for ETC status beyond the boundaries of the reservation are de minimus. In the future, if FDLCI wishes to expand its services beyond the reservation, the Commission may wish to participate in the request for expansion.
