**PLEASE TAKE NOTICE** that on May 5, 2021, Hayward Solar LLC filed an application for a certificate of need for the Hayward Solar project, a large (150 MW) energy facility as defined under Minn. Stat. § 216B.2421, subd. 2(1). A large energy facility cannot be constructed in Minnesota unless it receives a certificate of need (CN) from the Minnesota Public Utilities Commission (Commission), under Minn. Stat. § 216B.243. The rules governing the review of this project are found in Minn. Rules Chapter 7849. On June 29, 2021, the Commission issued an Order accepting the application as complete and directing the use of the informal review process for the matter.

An Environmental Assessment on the project and alternatives to it, is being conducted by the Minnesota Department of Commerce Energy Environmental Review and Analysis unit, on behalf of the Commission, under Minn. Rules 7849.1000 through 7849.2100.

A site permit application for the Hayward Solar Project (GS-21-113) is also being reviewed by the Commission in conjunction with this certificate of need application. The Environmental Report on the CN will be included as part of the Environmental Assessment for the project.
