In the Matter of the Application for a Site Permit Amendment to Repower the 200 MW Pleasant Valley Large Wind Energy Conversion System in Dodge and Mower Counties, Minnesota

PUC Docket Number: E-002/WS-09-1197

PLEASE TAKE NOTICE that the Minnesota Public Utilities Commission (Commission) and the Minnesota Department of Commerce will hold public information meetings on the application of Xcel Energy for an amendment to the site permit for the Pleasant Valley Wind large wind energy conversion system in Dodge and Mower counties.

Xcel Energy is proposing to repower the Pleasant Valley Wind facility to improve turbine technology, maximize energy yield, and extend the service life. The repower includes all 100 existing turbines and entails installing larger rotors, upgraded gear boxes, and associated nacelle components or replacing the entire nacelle. The locations of turbines, access roads, collection lines, point of interconnection, and other supporting infrastructure will remain the same. The upgrades will result in an increase in the overall facility production capacity from 200 megawatts to 220 megawatts. However, the overall capacity at the point of interconnection will remain at 200 megawatts in accordance with the existing generator interconnection agreement.

There will be two public meetings in this matter: an In-Person Meeting and a Remote-Access Meeting. The information presented will be the same at both meetings.
