Minnesota Power hereby electronically submits this Supplemental Information in the above-referenced Docket.

Minnesota Power files this Additional Supplemental Information in response to the July 31, 2013 Order from the Minnesota Public Utilities Commission in the Matter of Minnesota Power's 2012 Remaining Life Depreciation Petition Docket No. E015/D-12-378. Please see the attached file "Recalc of 2008-2012 Depr Res Impacts.xlsx" for the calculation of the estimated 2008-2012 impact on depreciation reserve of calculating the salvage rate using the gross salvage method instead of the net salvage method. The total estimated impact is \$4,471,200. Starting in October of 2013, Minnesota Power will record amortization expense of \$124,200 per month for the next 36 months. As a result, the estimated increase to 2013 annual depreciation expense will be \$1,317,381, not \$944,781 as filed in the initial filing. An Affidavit of Service is also included.
