On May 1, 2015, Qwest Corporation d/b/a CenturyLink (Qwest) filed a petition in the above referenced matter, proposing to increase the monthly rate for Private (non-published) and Semi-Private (non-listed)<sup>1</sup> Directory Service, from \$2.45 to \$3.45, and from \$1.15 to \$2.15, respectively, effective June 1, 2015.

On June 17, 2015, the Legal Services Advocacy Project (LSAP) filed comments in response to Qwest's petition.

The Department believes that the comments of LSAP raise important issues that the Commission may wish to consider with respect not only to Qwest, but to other carriers that provide directory listings services.

In light of the comments filed by LSAP, the Department wishes to provide comments and therefore requests an extension of the initial comment period to July 1, 2015.
