

NOTICE OF RENEWABLE ENERGY CERTIFICATE (REC) RETIREMENT FOR RENEWABLE ENERGY OBJECTIVES AND GREEN PRICING PROGRAMS

Issued: March 12, 2025

In the Matter of Commission Consideration and Determination of Compliance with Minnesota's Renewable Energy Objectives for Year 2024

In the Matter of the Green Pricing and Verification Filing Process

**PUC Docket Number(s): E-999/PR-25-12
 E-999/PR-02-1240**

All electric utilities subject to [Minn. Stat. § 216B.1691](#),¹ as well as those with Green Pricing Programs, must retire Renewable Energy Credits (RECs) and file annual verification reports for the Eligible Energy Technology Standard (EETS),² and Green Pricing Programs. Public utilities must also retire sufficient RECs to satisfy solar energy standard (SES) requirements. These retirements must be completed by May 1 of the year following the compliance year. For example, RECs for compliance (calendar) year 2024 must be transferred and retired by May 1, 2025. Additionally, utilities must provide the information requested in the reporting template below and file it no later than **June 2, 2025**. The reporting template may be found here:

With its December 6, 2023, Order in Docket E-999/CI-23-151,⁴ the Commission published a list of utilities newly subject to Minn. Stat. § 216B.1691. An up-to-date list of electric utilities currently subject to Minn. Stat. § 216B.1691 has been included at the end of this notice. Of note, electric utilities that provide power to one or more municipal or distribution utilities identified in the Commission's list of electric utilities are allowed to report on behalf of each electric utility they serve.⁵

PLEASE NOTE: Utilities should have received an invitation to retire RECs in the M-RETS dashboard under the program titled ‘Minnesota EETS 2024 Compliance,’ and if applicable, ‘Minnesota SES 2024 Compliance’ and ‘Minnesota SES Small Scale 2024 Compliance.’ For questions regarding the platform or invitations, please contact systemadmin@mrets.org. If your utility did not receive an invitation and believe you should have, please contact Commission Staff using the contact information provided at the end of this notice.

In accordance with Minn. Stat. § 216B.1691, subd. 2a, all electric utilities covered under Minn. Stat. § 216B.1691 must retire RECs representing **20 percent** of annual retail sales for calendar year 2024.⁶

Compliance will also be reviewed for Minnesota’s Solar Energy Standard under Minn. Stat. § 216B.1691, subd. 2f, which requires a public utility to generate or procure enough solar energy to supply at least 1.5% of its retail electric sales in Minnesota with solar energy by the end of 2020. Of the 1.5% solar requirement, at least 10% must come from solar photovoltaic devices with 40-kilowatt (kW) capacity or less. Public utilities with 50,000 to 200,000 retail electric customers may count individual customers’ community-solar garden subscriptions of 40 kW or less toward the 10% small-scale carveout.

Updates to Reporting Template: Pursuant to the Commission’s June 26, 2024 Order in Docket No. E-002, E-015, E-017/CI-23-403,⁷ Commission Staff updated the reporting template to include questions on public utilities’ preparedness to comply with the Distributed Solar Energy Standard (DSES). Staff sent this updated template to the Department and all electric utilities for review, and applied any proposed modifications.

Summary of all changes made to template:

- A new DSES sheet, complete with the information required in the 23-403 Order
- Renaming the RES the “EETS” consistent with statutory modifications
- Renaming the worksheet the “Renewable Energy Certificate Retirement Report for **Renewable Energy Objectives** and Green Pricing Programs” to acknowledge that the template contains compliance information for more than just the EETS and green pricing.
- Updated the Utility Info tab to more clearly articulate what information we are looking for when a utility is retiring RECs on behalf of another electric utility.

Biennial Reporting: Please note, worksheet 7 of the reporting template addresses the filing requirements for the biennial reporting obligation and is only included in years in which the

biennial report requirement applies. This year is not a biennial reporting year, and so Staff has hidden worksheet 7 to reduce confusion. Utilities are required to file this information pursuant to the Commission's May 28, 2013 Order Finding Utilities In Compliance With Minn. Stat. § 216B.1691 And Modifying Biennial Reporting Procedures,⁸ in Docket No. E-999/M-12-958, and its December 6, 2023 Order Clarifying Implementation of Changes to Minn. Stat. § 216B.1691 and Directing Additional Comment Period⁹ in Docket No. E-999/CI-23-151.

Solar Energy Standard (SES): Please note worksheet 4 of the spreadsheet addresses the filing requirements for the SES reporting obligation per the Commission's [January 29, 2021 Order](#) and Attachment 1 in Docket No. E-999/M-20-464. Only public utilities subject to this subdivision need to report on SES compliance.

Distributed Solar Energy Standard (DSES): Worksheet 5 addresses public utilities' compliance with the DSES. Please note, REC retirements for DSES compliance are not required until reporting year 2030. However, per the Commission's June 26, 2024 Order in Docket No. E-002, E-015, E-017/CI-23-403,¹⁰ public utilities are expected to provide information in the years leading up to 2030 on their preparedness to meet the standard.

Eligible energy facilities: RECs retired for RES compliance must originate from eligible energy technology as defined by Minn. Stat. § 216B.1691, subd. 1.

REC shelf life: Only RECs retired before the end of their Commission-designated shelf life (the year of generation plus four years) will be counted towards either the RES requirement or a utility's Green Pricing Program. Solar Renewable Energy Credits (SRECs) for the SES also have a four-year shelf life. SRECs generated before 2020 were granted longer eligibility per the Commission's April 25, 2014, order in Docket No. E-999/CI-13-542.¹¹ However, the shelf life of SRECs generated before 2020 has since expired.

M-RETS REC retirement platform: Utilities should have been invited to the Minnesota RPS 2021 Compliance program and, for certain public utilities, the Minnesota Small Solar program via M-RETS account holders.
