RE: Comments of the Minnesota Department of Commerce Docket No. E999/M-23-91

Dear Mr. Seuffert:

The Minnesota Department of Commerce (Department) reviewed the 2023 Biennial Transmission Projects Report (Report) for compliance with Minnesota Rules 7848.1300 and the Minnesota Public Utilities Commission's (Commission) June 29, 2022 Order on the 2021 Biennial Transmission Projects Report. The Department has reviewed the Report and concludes that the required information is located either in the Report or in the referenced Midcontinent Independent System Operator (MISO) Transmission Expansion Plan.

Minnesota Rules 7848.1300 B requires "a copy of the most recent regional load and capability report of the Mid-Continent Area Power Pool [MAPP] or other appropriate regional reliability council." As MAPP no longer exists², the Report included the North American Electric Reliability Corporation's (NERC) 2022 Long-Term Reliability Assessment as Appendix A of the Report.

Additionally, Minnesota Statutes § 216B.2425, subds. 2(e) and 8 contain two additional requirements for utilities operating under multiyear rate plans. Northern States Power Company d/b/a Xcel Energy is the only utility operating under a multiyear rate plan and the requirements were addressed in section 2.6 of the Petition.
