











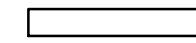


## FIGURE 1.1 Proposed Route Overview

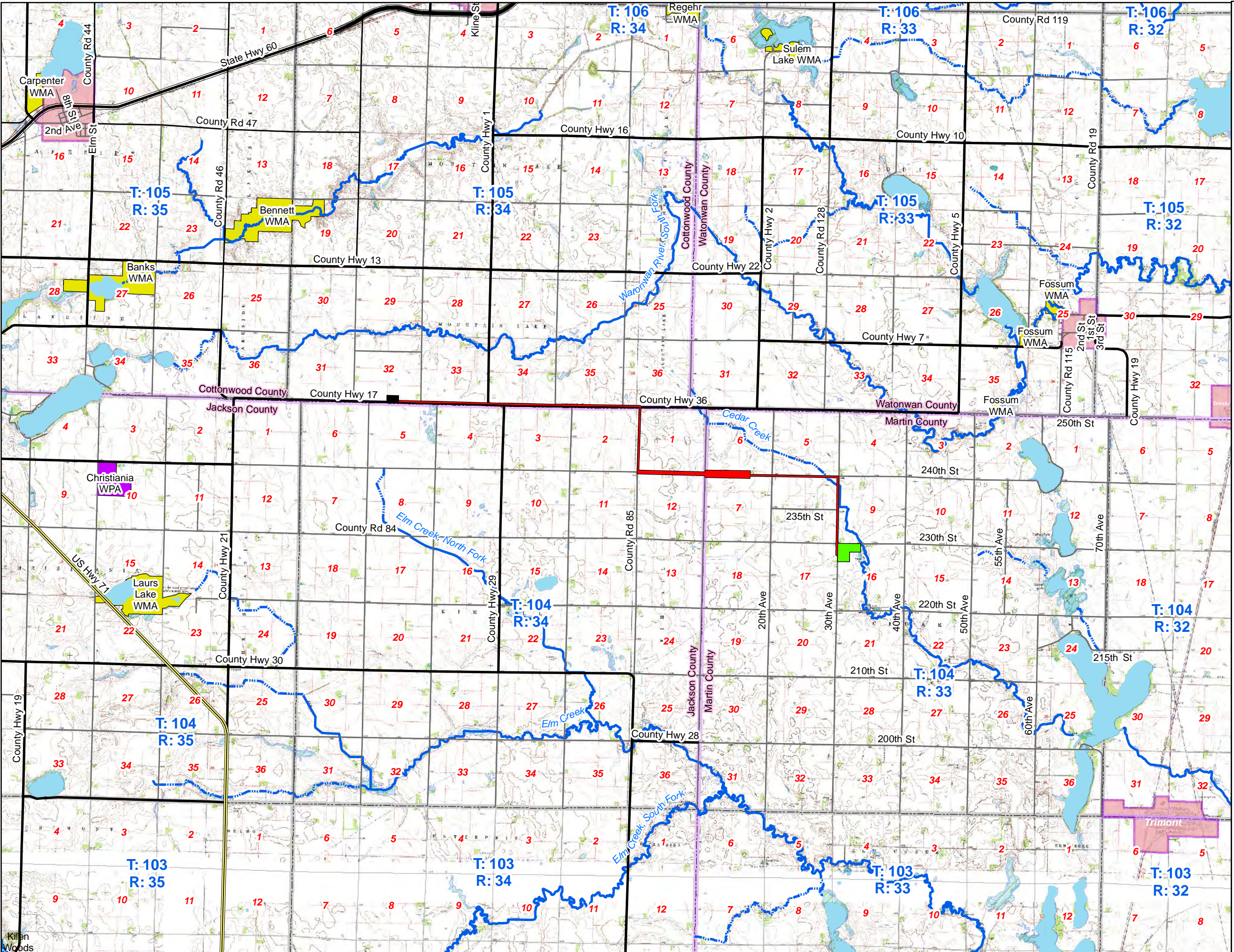
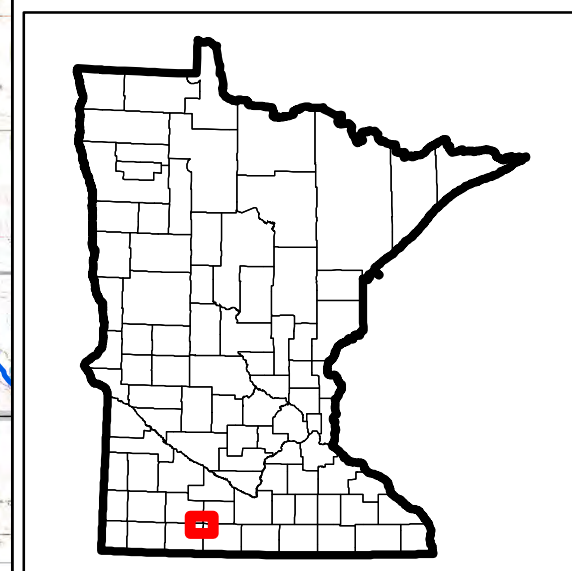
**FIGURE 2.1**



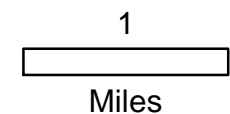




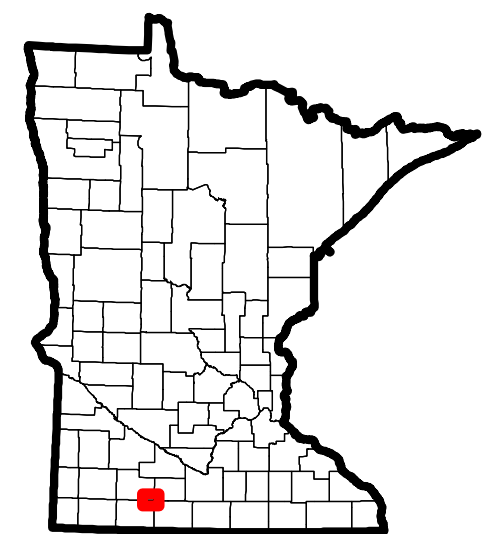
**FIGURE 3.1**

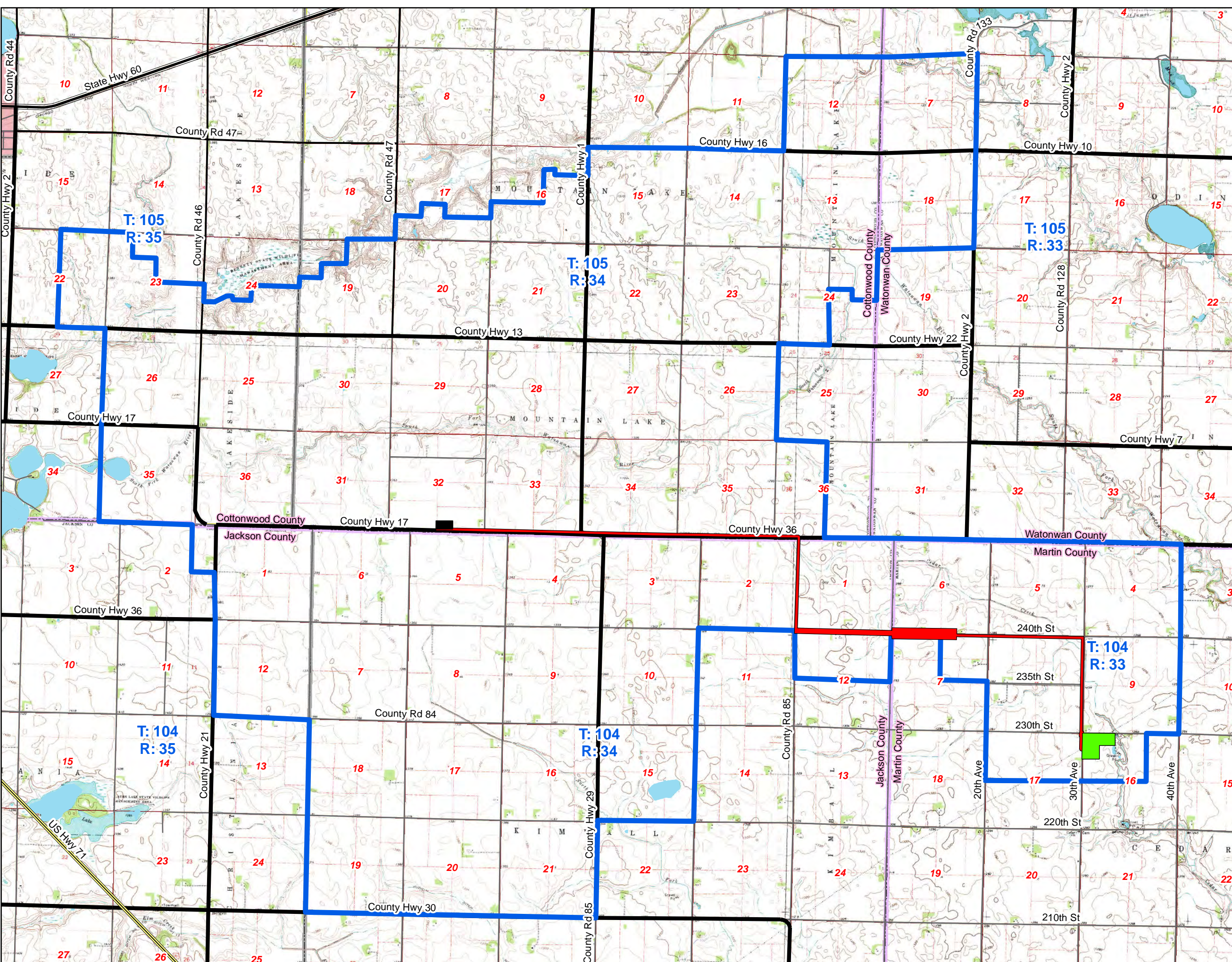

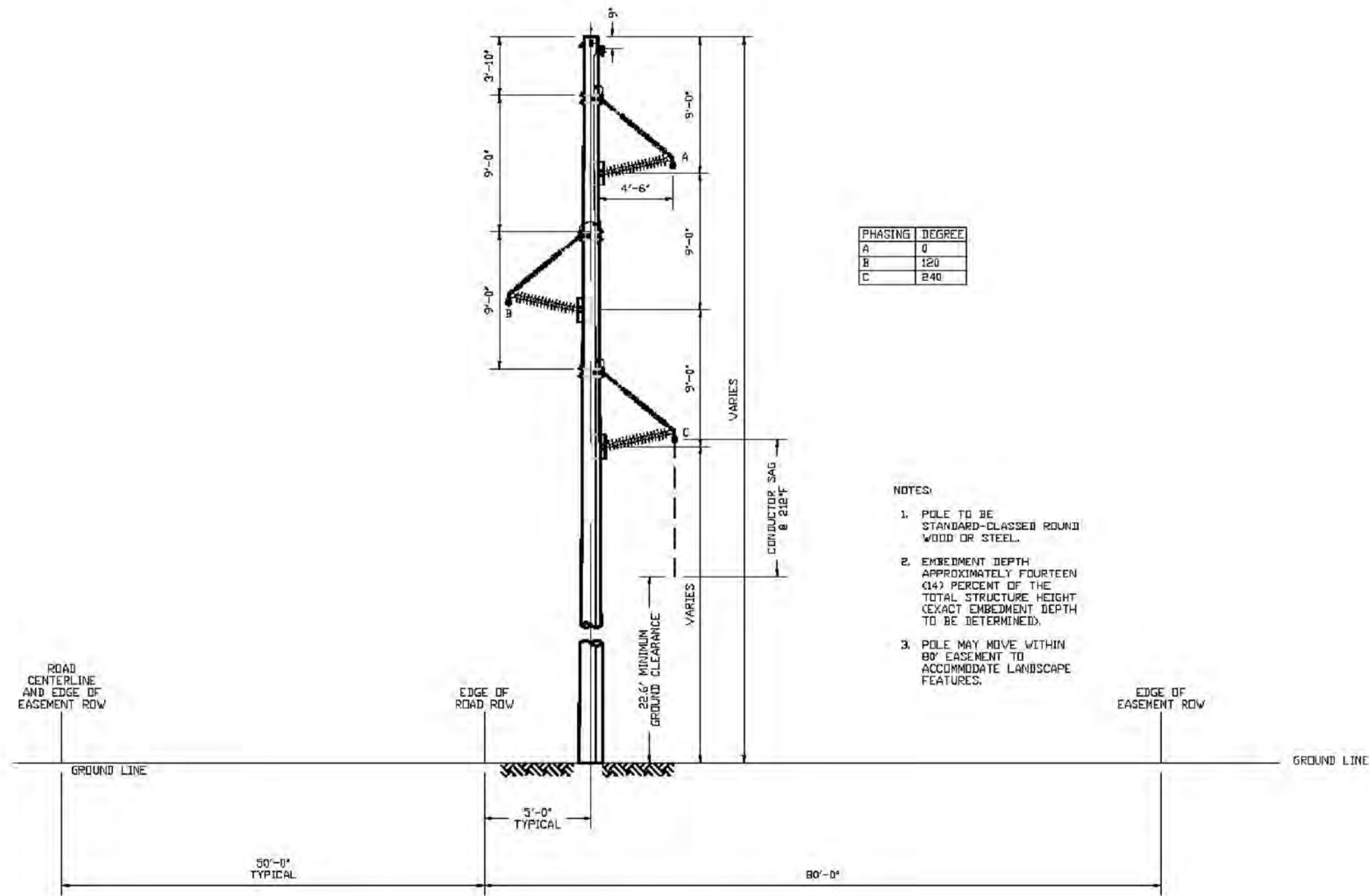

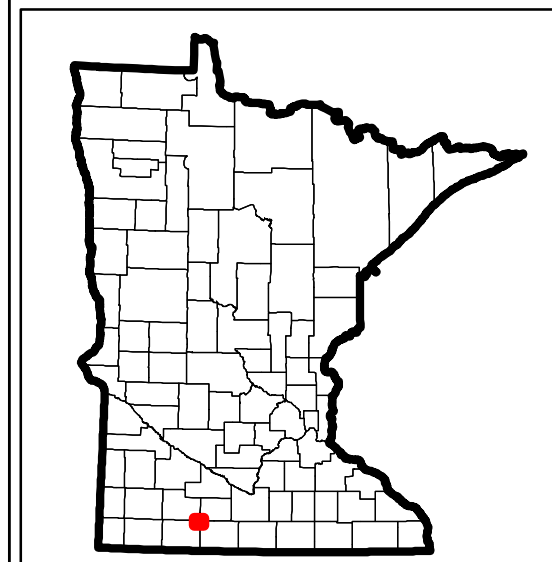

(Vertical Configuration)**

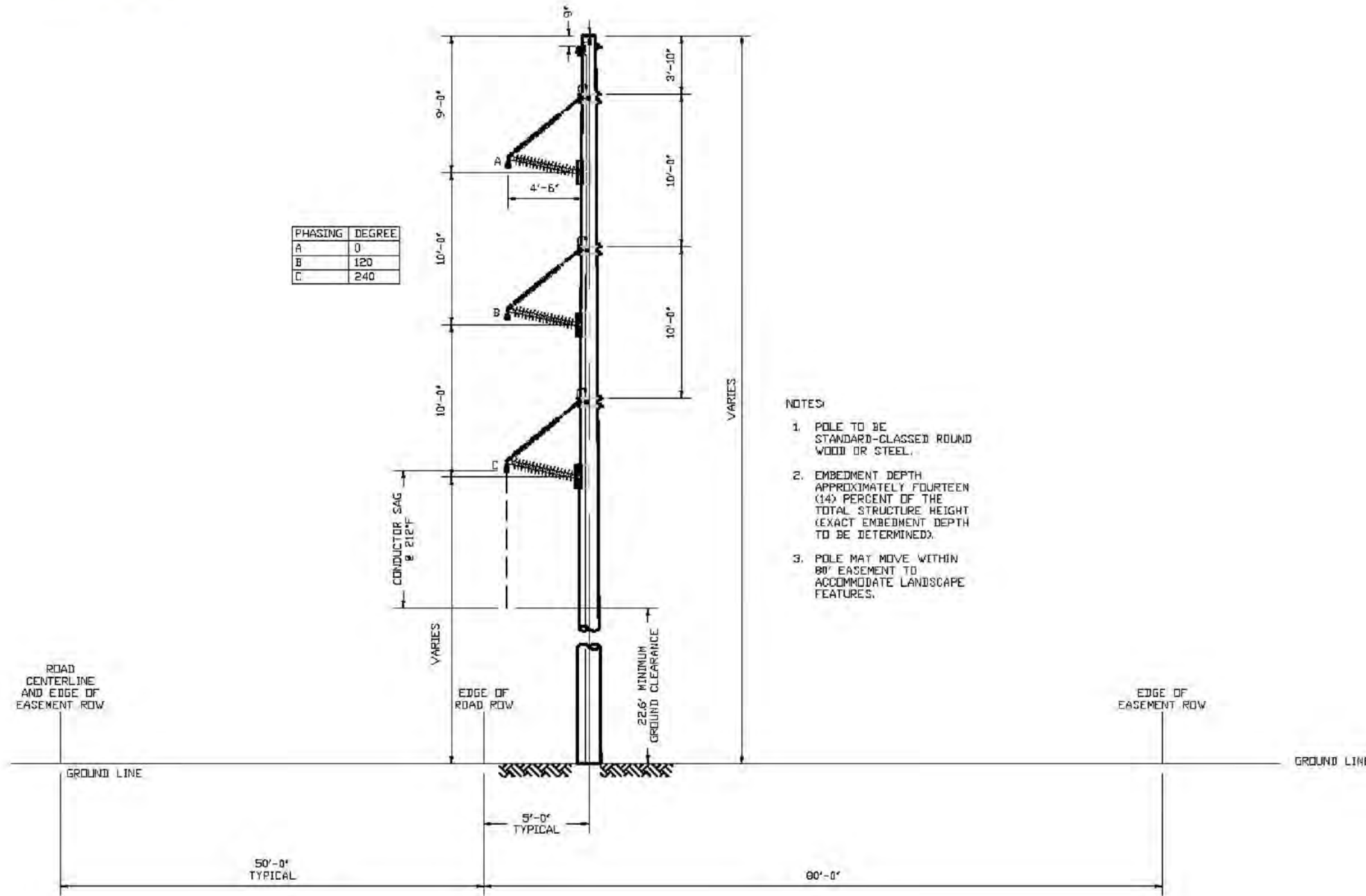
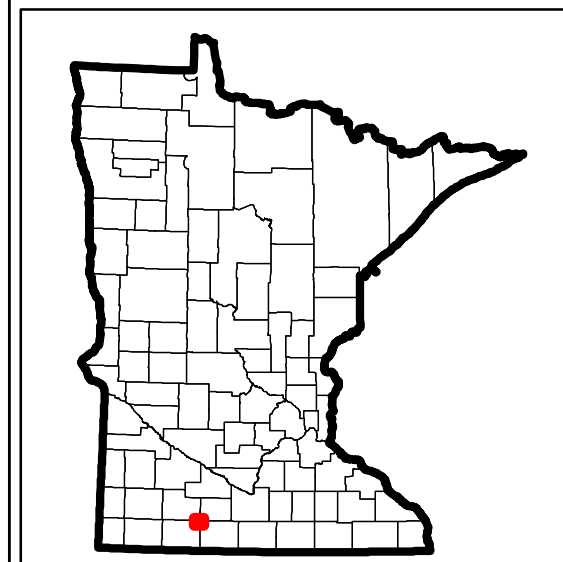







FIGURE 2 - PROPOSED VERTICAL CONFIGURATION STRUCTURE AND EASEMENT RIGHT-OF-WAY CORRIDOR

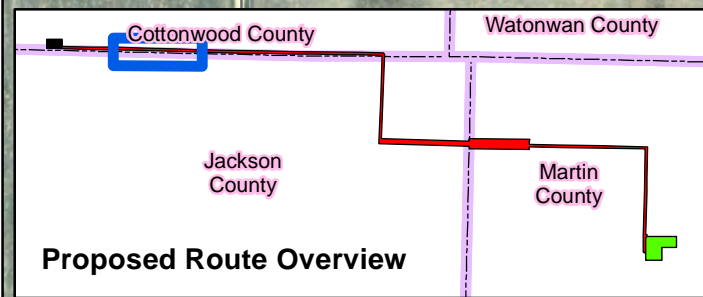
**FIGURE 5.2 (b)**

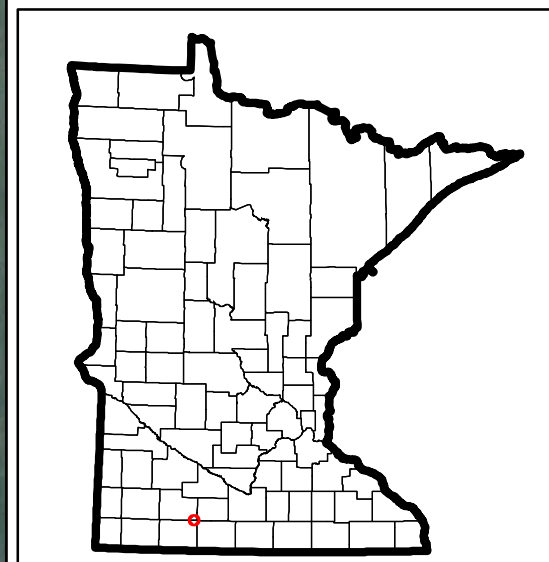
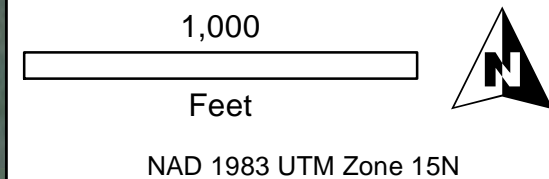




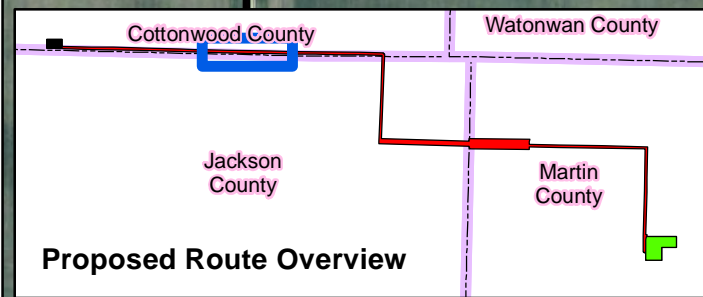
**FIGURE 5.2 (c)**

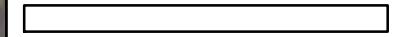


**FIGURE 5.2 (d)**

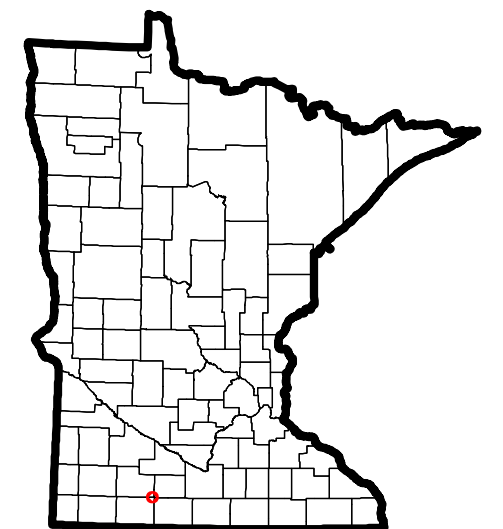

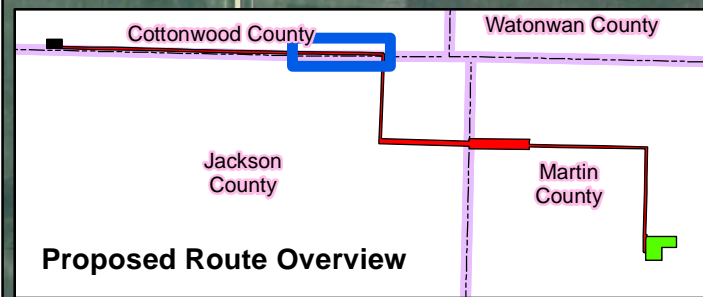

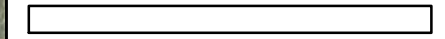


**FIGURE 5.2 (e)**

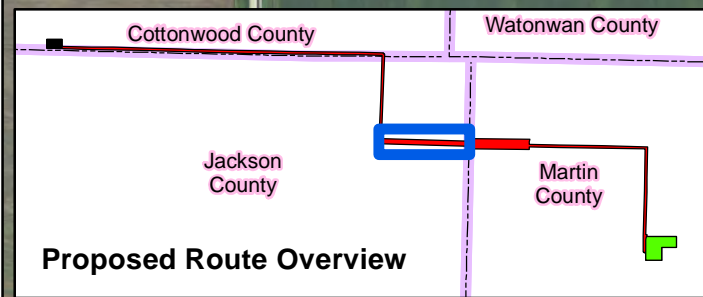
**FIGURE 5.2 (f)**

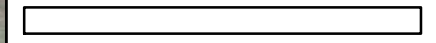


**FIGURE 5.2 (g)**

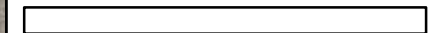


**FIGURE 5.2 (h)**

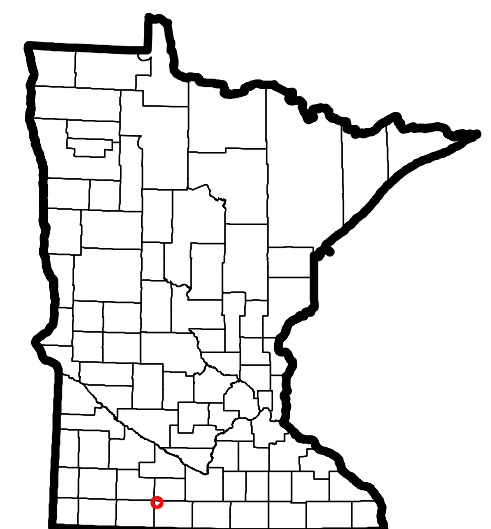
**FIGURE 5.2 (i)**

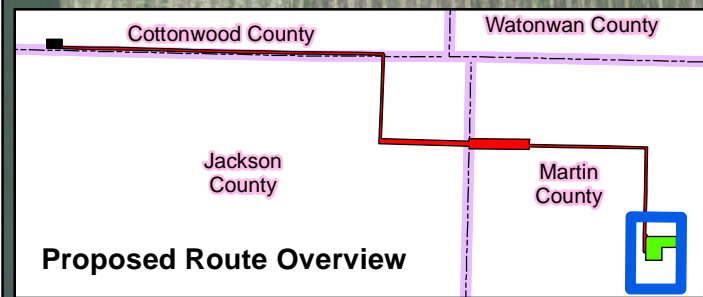
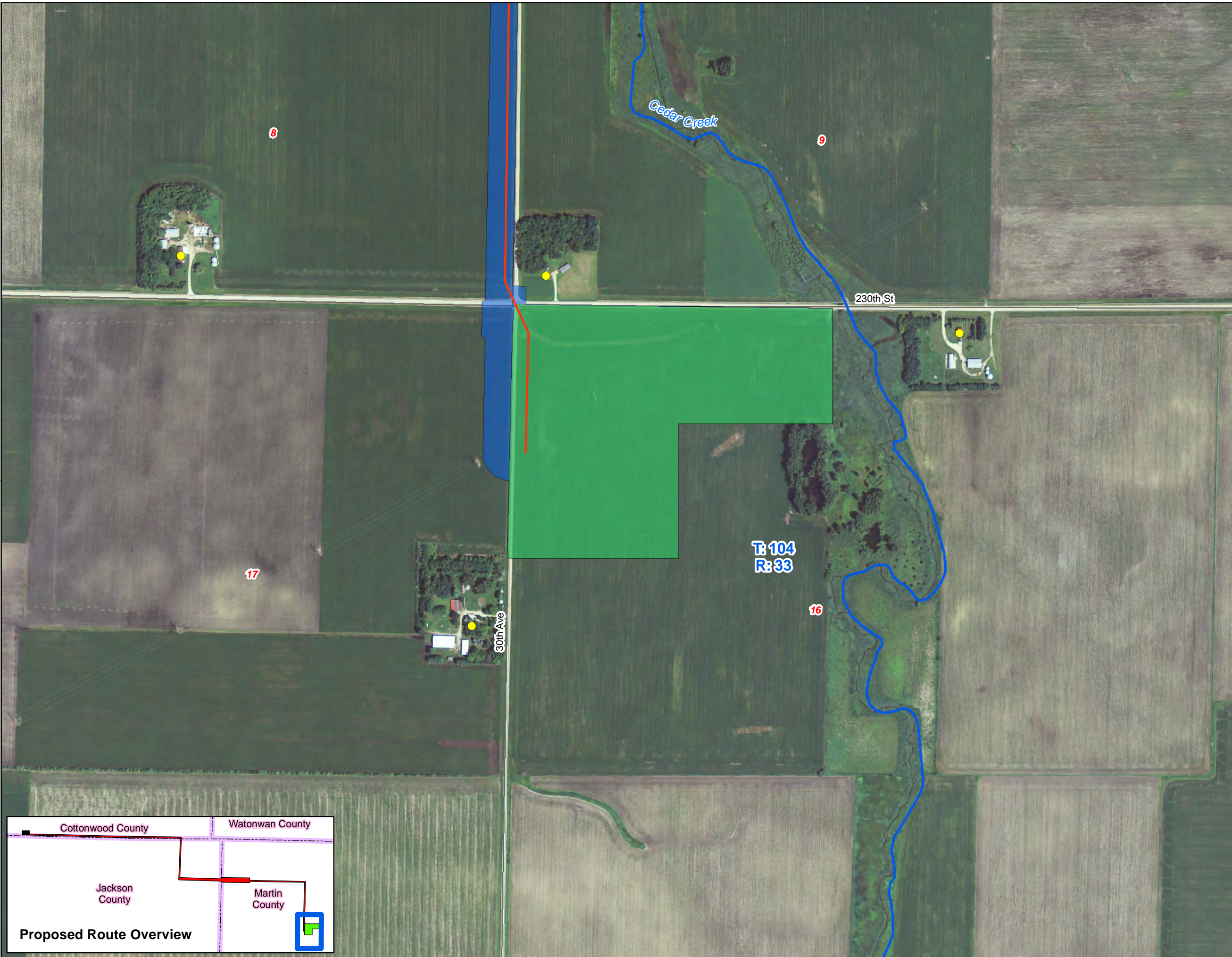
**FIGURE 5.2 (j)**







**FIGURE 5.3**
