National Grid Renewables' Withdrawal from Settlement Agreement

Dear Secretary Seuffert:

I write in response to the Minnesota Public Utilities Commission's ("Commission") April 21, 2025 Order ("Order")<sup>1</sup> approving the Settlement Agreement filed in the above-captioned dockets ("Settlement Agreement"),<sup>2</sup> subject to certain modifications. Pursuant to Section IV(D) of the Settlement Agreement, and for the reasons stated below, National Grid Renewables Development, LLC ("National Grid Renewables") hereby notifies the Commission and other parties that it is withdrawing from the agreement due to these modifications and other issues described below.

In its comments in support of the Settlement Agreement, National Grid Renewables expressed its opposition to a proposed modification that would have capped the price for bidder projects at the as-bid price.<sup>3</sup> Nonetheless, in the Order, the Commission approved the Settlement Agreement, subject to a modification that caps the prices for all bids listed in Section III(A)(1) of the Settlement Agreement "at bid amounts as of October 2, 2024, unless Xcel demonstrates by

substantial evidence that additional costs were caused by events outside of Xcel's control and are otherwise prudent.”<sup>4</sup> The Commission further modified the Settlement Agreement by indicating it will use certain factors—which, again, were not initially included in the agreement—to evaluate the reasonableness of power purchase agreements (“PPAs”) between Xcel Energy and the bidders.<sup>5</sup>

These modifications fundamentally alter the terms of the Settlement Agreement to which National Grid Renewables initially stipulated. The company does not believe the price cap the Commission imposed is in the public interest and would not have joined the agreement if this term was included in the agreement in the first instance. Therefore, National Grid Renewables is exercising its right to withdraw from the Settlement Agreement, pursuant to Section IV(D).

In addition to these changes to the Settlement Agreement, recent economic and political developments make it infeasible for National Grid Renewables to negotiate a PPA with Xcel Energy for the Plum Creek Wind + Storage Project (“Project”) on the timeline set forth in the Settlement Agreement and at the as-bid price. For example, and as National Grid Renewables explained in its previous comments, the Project has faced numerous delays because of the Midcontinent Independent System Operator, Inc. (“MISO”) interconnection process: MISO still has yet to release Definitive Planning Phase 2 study results for the Project, which is one of several required milestones before a Generator Interconnection Agreement (GIA) can be executed. Those study results will likely impact the Projects’ costs and construction timeline.<sup>6</sup> At this point, without certainty regarding the Project’s interconnection upgrade costs, executing an offtake contract would introduce additional risk for both National Grid Renewables and Xcel.

In addition, tariff policies have and will continue to impact costs and supply chains for renewable energy projects, including the Plum Creek Project. Biden administration-era tariffs on battery parts and lithium-ion phosphate batteries are affecting battery energy storage system (“BESS”) costs for the Project.<sup>7</sup> Likewise, recent reciprocal tariffs from the Trump administration have introduced many new risks to supply chains across the economy, including a 125 percent duty on Chinese-made goods, as of April 10, 2025. This is contributing to rapid and significant cost uncertainty, delays, and tightening bottlenecks around hardware critical to project development. These and other tariffs present challenges for project development and the high likelihood that as-bid prices for new renewable projects from almost eighteen months ago will not reflect the realities of currently accrued costs.

In sum, along with unforeseen delays in the MISO generator interconnection queue, these recent political and economic disruptions have affected the industry, exacerbating uncertainty for

market participants. Importantly, all these issues are completely outside National Grid Renewables' and Xcel's control.

To be clear, National Grid Renewables firmly believes that renewable energy paired with storage can provide clean, firm capacity for Minnesota utilities. Should Xcel wish to discuss potential substitutions for the Project, noting that the ambiguity and uncertainty related to interconnection, policy, and economics discussed above impacts the industry as a whole, we would be open to that discussion. We further believe that competitive bid solicitations such as this one can promote the public interest by leading to lower costs for ratepayers.

However, the Commission's modifications to the Settlement Agreement, as well as the cumulative, unforeseen impact of the interconnection delays, procurement uncertainties, and permitting and political issues described above, make it infeasible for National Grid Renewables to negotiate and execute a PPA with Xcel Energy for the Project at this time. We look forward to future opportunities to work with Xcel, other utilities, and the Commission on clean energy solutions that will help secure a safer, more reliable, and more sustainable energy future for the state of Minnesota.
