RE: Response Letter of the Minnesota Department of Commerce Docket No. E015/AA-25-64

Dear Mr. Bull:

On May 1, 2025, Minnesota Power (MP or the Company) filed its <u>2026 Annual Forecasted Fuel and Purchased Energy Rates</u> for the calendar Year 2026 with the Minnesota Public Utilities Commission (Commission).

On June 24, 2025, the Minnesota Department of Commerce (Department) filed <u>Comments</u> recommending the Commission approve the Company's 2026 Fuel Forecast, subject to a subsequent true-up, and pending the results of the Midcontinent Independent System Operating (MISO) Planning Resource Auction (PRA) provided by MP in Reply Comments.

On July 31, 2025, the Company filed Reply Comments, stating that the results of the MISO PRA for June 2025 through May of 2026 were filed in MP's new Capacity and Revenue Expense (CRE) Rider on May 1, 2025. The CRE Rider is part of the Company's implementation of its 2023 rate case Compliance Filing. MP notes that with final rate implementation on March 1, 2025, short-term capacity revenues (previously included in the Fuel Adjustment Clause Forecast) and short-term expenses (previously included in base rates), were transitioned to the new CRE Rider. The Department has reviewed the CRE Rider and notes MP will update the MISO planning year of monthly CRE Rider rates on May 1 of each year, shortly after the MISO PRA results become available.²

On July 2, 2025, the Department filed <u>Comments</u> in the CRE Rider docket, recommending the Commission find the forecasted capacity revenue amounts included in Attachment 1 of the Petition to be reasonable. This docket is pending Commission review.

The Department notes MP did not make any changes to the 2026 Fuel Forecast and Purchased Energy rates in its Reply Comments. As a result, the Department recommends the Commission approve Minnesota Power's 2026 Fuel Forecast, subject to a subsequent true-up, and is available to answer any questions the Commission may have.
