#### **Topic(s) Open for Comment:**

- Should the Commission undertake a rulemaking proceeding to amend Minnesota Rules chapter 7825?
- Are there other issues or concerns related to this matter?

#### **Background**

On January 7, 2026, the Commission received a petition for rulemaking under Minnesota Statutes section 14.09 from Utility Reform Now. The petitioner requested that the Commission undertake a rulemaking proceeding under the Administrative Procedure Act to amend Minnesota Rules chapter 7825 either to include certain policy statements issued by the Commission on April 14, 1982, and June 14, 1982 (attached to the petition as Schedule 2), or to adopt other rules to govern rate cases for natural gas utilities and electric utilities. The full petition is available in eDockets (see instructions below to access the docket).

Minn. Stat. § 14.09 requires the Commission to respond as to its planned disposition of the petition within 60 days of receipt.

**Filing Requirements:** Utilities, telecommunications carriers, official parties, and state agencies are **required** to efile documents using the Commission's electronic filing system (eFiling). All parties, participants, and interested persons are encouraged to use eFiling at:
