Dear Dr. Haar:

Under a separate eFile submission, dated today, please find the Great River Energy (Applicant) combined Certificate of Need Application and Route Permit Application (Application) to construct approximately 5.4 miles of new double circuit 115 kilovolt (kV) transmission line and to rebuild approximately 11.3 miles of existing 69 kV transmission line to 115 kV specifications in the Elko New Market and Cleary Lakes areas south of the Twin Cities metro area in Scott and Rice counties, Minnesota (Project). The Application details the Applicant's need for and proposed route for the Project.

The Project is needed to address low voltage and transmission system overload issues in these areas. The existing transmission system that serves this area of the state has reached its maximum peak load-serving capability.

The Certificate of Need Application is submitted under Minnesota Rules 7849.0010 to 7849.2100 and Minnesota Statutes Section 216B.243. The "original" paper Application, three paper copies of the Application, and a CD ROM of the Application have been provided to the Minnesota Public Utilities Commission. One paper copy and one CD ROM of the Application have been provided to Dr. Steve Rakow of the Department of Commerce, Division of Energy Resources Staff.

A check for \$3,650 made payable to the Minnesota Public Utilities Commission for 25% of the total estimated fee for processing the Certificate of Need application (as required by Minn. R. 7849.0210 and Minn. Stat. § 216B.243, subd. 6) has been provided to the Minnesota Public Utilities Commission.

The Route Permit Application is submitted under the Alternative Permitting processes of Minn. Rules 7850.2800 to 7850.3900 and Minn. Stat. § 216E.04. An electronic copy on CD ROM and 6 paper copies of the Application have been provided to David Birkholz of the Department of Commerce, Energy Facility Permitting Staff.


