Dear Mr. Wolf:

On November 15, 2016, Northern States Power Company, doing business as Xcel Energy, and Agralite Electric Cooperative submitted a petition seeking approval of an Electric Service Territory Agreement (Agreement) between the two parties. Upon further review, we determined our filing needed more clarity.

The reason the Agreement is necessary is because the electronic version of the Electric Utility Service Area (EUSA) map does not match the paper service area map and that correction did not get updated during the earlier review of the electronic version of the map in Docket No. E999/CI-12-957. This error was discovered recently when reviewing some plans for a new building in this area. So, while there are no existing facilities or customers impacted by the Agreement, there will be a customer there in the future.

The attached map (Attachment A to this letter) shows the proposed correct line in purple, the existing incorrect line in yellow, and Xcel Energy's correct service territory in orange.

We have electronically filed this document with the Minnesota Public Utilities Commission, and copies have been served on the parties on the attached service list.

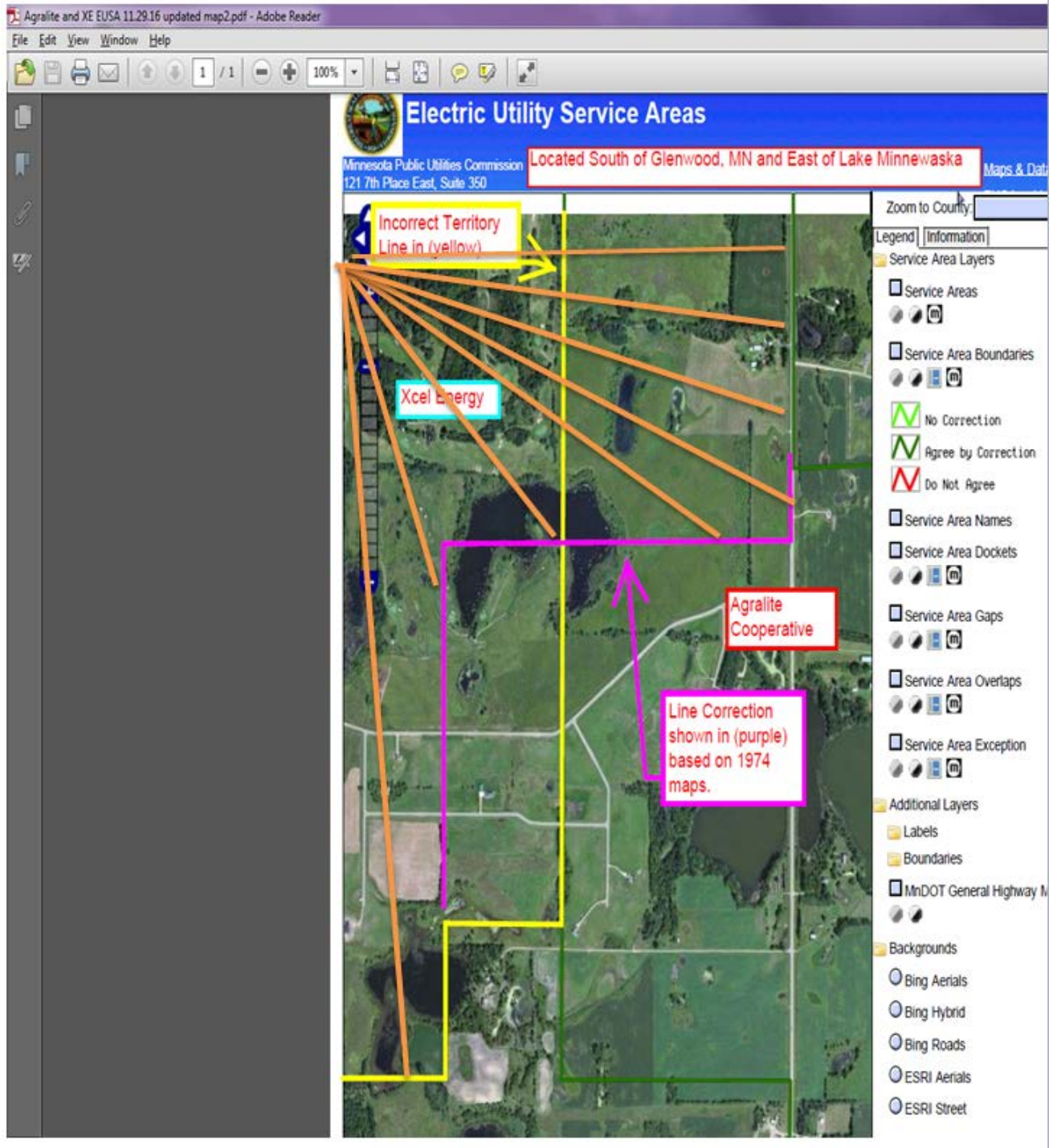
