Statement in Support of the Filing

Summary of the Filing

On May 1, 2015, Qwest Corporation, d/b/a CenturyLink QC submits a tariff filing to increase its rates for Private and Semi-Private Directory Listings in Minnesota. The proposed effective date is June 1, 2015.

Rationale

One of CenturyLink's strategic initiatives is to standardize rates across all territories within the Company. Based on historical Company tariffs, the rates for Private and Semi-Private Directory Listings have not increased since at least October 1984. With this filing, the Company moves toward more consistent and uniform rates throughout its legacy Qwest region.

In addition, this increase is intended to address revenue challenges of the Company. Private and Semi-Private Directory Listings are a specialized, discretionary service offering to which customers have the ability to subscribe or unsubscribe at will.

The annual revenue impact of this increase for legacy Qwest in Minnesota is estimated to be as follows:

- Business and Residence forecasted increase is being determined and will be provided when available.

Customer Impacts and Notification

The customer notice originally included in the filing was revised prior to sending to Minnesota customers. The following message will be included in subscriber bills in the month of May:

NOTICE OF PRICE INCREASE: Effective June 1, 2015, the monthly rate for non-published and non-Listed telephone numbers will increase by \$1.00. Effective July 1, 2015, the following monthly charges will be implemented: a late payment charge assessed on unpaid balances for local service will be implemented to the greater of 1.5% or \$5.00; the late payment fee for High-Speed Internet will increase to \$7.00; all Directory Assistance calls completed by your local telephone company will increase by \$1.00/call; and the convenience fee for one-time payments completed with the assistance of a CenturyLink representative will increase to \$5.00/payment.
