Dear Mr. Seuffert:

Great River Energy respectfully submits these comments regarding the Administrative Law Judge's Findings of Fact, Conclusions of Law, and Recommendations ("Report"). The Report recommends that the Minnesota Public Utilities Commission ("Commission") grant a route permit for the Pilot Knob to Burnsville Rebuild and Upgrade Project ("Project"), with certain conditions. Great River Energy appreciates the Administrative Law Judge's thorough review of the record and recommendation to grant a rout permit for the Project.

Great River Energy provides one clarification regarding the Report's description of the proposed conductors to be used for the Project. Specifically, Great River Energy requests that Paragraph 57 of the Report be revised to include the underlined language below:

Single circuit structures would have three phases of bundled conductor wires and one shield wire. <u>Double circuit structures</u> would have six phases of bundled conductor wires and up to two shield wires. It is anticipated that the phase wires would be 795 thousand circular mil aluminum-clad steel supported (795 ACSS) or a conductor with similar capacity.¹

This revision is consistent with the record and the Report, in that the Report elsewhere recommended incorporating Great River Energy's revisions to Section 2.2 of the Draft Route Permit, which included the text above.²

Separately, with respect to proposed permit conditions, the Report generally recommends that the Commission include the permit conditions proposed by Great River Energy and further revised by the Department of Commerce, Energy Environmental Review and Analysis ("EERA"). Great River Energy appreciates EERA's coordination regarding the proposed permit conditions and respectfully submits that the proposed conditions identified in the Report resulting from that coordination are workable and avoid and minimize potential Project impacts.
