ORDER ACCEPTING APPLICATIONS AS COMPLETE, ESTABLISHING PROCEDURAL REQUIREMENTS, AND NOTICE OF AND ORDER FOR HEARING

**PROCEDURAL HISTORY**

On April 2, 2024, Northern States Power Company, doing business as Xcel Energy (Xcel or the Applicant), filed a joint application for a Certificate of Need (CN) and Route Permit for the Mankato-Mississippi River Transmission Project (the Project). The Project includes: (1) a new, 130-mile, 345-kilovolt (kV) transmission line between the existing Wilmarth Substation in Mankato and the Mississippi River, and (2) a new, approximately 20-mile 161-kV transmission line between the North Rochester Substation near Pine Island and an existing transmission line northeast of Rochester. The Project may cross portions of Blue Earth, Le Sueur, Waseca, Rice, Dodge, Olmstead, Goodhue, Winona, and Wabasha counties. As proposed, the project is divided into four segments.

By April 22, 2024, the Commission received comments on the applications from:

- the Department of Commerce, Energy Environmental Review and Analysis Unit (EERA);
- the Department of Commerce, Division of Energy Resources (the Department);
- the Prehn family and NoCapX 2020;
- Midcontinent Independent System Operator (MISO);
- members of the public<sup>1</sup>.

By April 30, the Commission received reply comments from:

- Xcel Energy;
- the Prehn family and NoCapX 2020;
- the International Union of Operating Engineers Local 49 and North Central States Regional Council of Carpenters (IUOE Local 49 and Carpenters);
- the Minnesota Center for Environmental Advocacy, Audubon Upper Mississippi River; Center for Rural Affairs; Citizens Utility Board; Clean Grid Alliance; Fresh Energy; Sierra Club; and Union of Concerned Scientists (the Joint Commenters); and
- the City of Oronoco<sup>2</sup>.

On May 6, 2024, Xcel Energy and the Department submitted supplemental comments.

On May 30, 2024, the application came before the Commission.

## **FINDINGS AND CONCLUSIONS**

### **I. The Project**

The Project is divided into the following four segments:

- Segment 1: construction of a new 48- to 54-mile 345-kV transmission line between the Wilmarth Substation and a point near the West Faribault Substation;
- Segment 2: construction of a new 34- to 42-mile 345-kV transmission line from a point near the existing West Faribault Substation to the existing North Rochester Substation;
- Segment 3: conversion of 27 miles of existing 161/345-kV transmission line to 345/345-kV operation, along with installation of a new 16-mile 345-kV circuit on the existing 345/345-kV double-circuit capable structures between the existing North Rochester Substation and the Mississippi River; and
- Segment 4: construction of a new 19.6-to 23.7-mile 161-kV transmission line between the existing North Rochester Substation and the existing 161-kV Chester Line northeast of Rochester.

The Project will also include upgrades at the Wilmarth, North Rochester, and Eastwood substations.

Along most of the proposed alignments, Xcel proposed a route width of 1,000 feet – including 500 feet on either side of the proposed center lines. In certain sections – including project

substations, locations with routing constraints, and sites where route options come together – Xcel proposed a width of up to 1.25 miles.

According to the Applicant, this Project – along with other Long Range Transmission Projects that were studied and approved by MISO – are needed to provide reliable, resilient, and cost-effective energy delivery as the generation resource mix continues to evolve. The Applicant stated that, along with other projects, this Project will provide transmission outlets for renewable energy in Minnesota, North Dakota, and South Dakota. The applicant further stated that this Project is needed as one of many to address loading and congestion issues on the existing 345-kV transmission system across southern Minnesota and Wisconsin.

Although Xcel will act as the project manager for the Project, it is anticipated that portions of the Project will be either individually or jointly owned by Xcel, Dairyland Power Cooperative, Southern Minnesota Municipal Power Agency, and the City of Rochester. However, Xcel is the sole applicant for the CN and route permit.

Xcel anticipates project construction starting in 2026, and the Project is scheduled to be in service by 2030. The estimated cost of the project is between \$524.7 and \$577.2 million.

## **II. Application Completeness and Review Procedures**

The Applicant filed its joint application under Minn. Stat. § 216B.243 (the certificate of need statute) and Minn. Stat. Ch. 216E (the route permitting statute). Xcel previously requested, and the Commission approved in its December 12, 2023 order, exemptions from certain CN filing requirements under Minn. R. Ch. 7849.

Under the certificate of need statute, any entity seeking to construct a large energy facility must first obtain a certificate of need from the Commission. Minn. Stat. § 216B.2421, subd. 2(2), defines a large energy facility as any high-voltage transmission line with a capacity of 300 kV or more and a length greater than one mile.<sup>3</sup>

Under Minn. Stat. § 216E.01, subd. 4, a high-voltage transmission line includes a conductor of electric energy and associated facilities exceeding 1,500 feet in length that are designed for and capable of operation at a nominal voltage of 100 kV or more. Under Minn. Stat. § 216E.02, subd. 2, construction of a high-voltage transmission line requires a routing permit from the Commission.

The Applicant states that the Project meets the definition of a high-voltage transmission line under Minn. Stat. § 216E.01, subd. 4, because it would be a conductor of electric energy with associated facilities designed for and capable of operation at a nominal voltage of 100 kV or more and greater than 1,500 feet in length. The Applicant states that the *route permit* must be reviewed under the full permitting process of Minn. Stat. § 216E.03 and Minn. R. 7850.1700 to 2700, but requested that the Commission review the *CN application* under the informal review process outlined in Minn. R. 7829.1200.

EERA<sup>4</sup>, IUOE Local 49 and Carpenters, MISO, and the Joint Commenters all recommend that the Commission find the applications complete under Minn. R. 7849.0200, subp. 5 and 7850.2000.

With the exception of the Prehn family and NoCapX 2020, all commenters agreed with the Applicant's request for the CN application to be reviewed under the informal review process in Minn. R. 7829.1200. Reasons cited for using the informal review process included: the need to expedite review and approval of the project to prevent reliability issues for the projected future transmission system; the need to provide opportunities for efficient use of intervenors' limited resources in cases without substantive disputes; and sufficient opportunities in the informal process to provide for environmental evaluation, a public hearing, and written comments. The Prehn family and NoCapX 2020 requested referral of the CN application to the Office of Administrative Hearings (OAH) for a contested case hearing. Citing the high voltage and significant length of the Project, they argue that contested issues of fact will emerge throughout the Project review process. They did not include any issues of fact that they specifically argued are contested at this time.

The Prehn family and NoCapX 2020 also raised a number of arguments regarding application completeness, including that the application fails to discuss: an existing underground gas storage facility in the project area, an identification of all homesteads within at least one-half mile of the proposed route, the potential for corrosive impact of transmission lines on pipelines, potential cumulative impacts on other transmission lines in the area, the need for a new easement if the full route does not fit within the existing easement, line losses, reactive power, electric and magnetic fields, socioeconomic impacts, property tax impacts, and an identification of the full system megawatt loading used in the modeling.

The Commission has considered the concerns raised by the Prehn family and NoCapX 2020 and determines that these issues would be best considered and addressed as part of the scoping process and further record development. The Commission also agrees with EERA, which argued that any contested issues can be addressed through the contested case hearing process that is required under the full permitting process for the route permit.

The Commission concurs with the Applicant and the remaining parties that the joint application is complete and will accept it as such.

The Commission also agrees with the Applicant that the full permitting process established in Minn. Stat. § 216E.03 and Minn. R. 7850.1700-2700 is appropriate for review of the Project and will authorize the use of this process.

The Applicant satisfactorily addressed these concerns in its reply comments, including by filing revised maps and providing confirmation of its analysis.

Additionally, the Commission will authorize the CN proceedings to follow the informal review process permitted in Minn. R. 7829.1200. This process is sufficient to allow for robust public participation and record development, and no contested issues of fact have been identified that would require a contested case on this matter in addition to the processes required under the full permitting process of Minn. Stat. § 216E.03 and Minn. R. 7850.1700 to 2700.

### **III. Advisory Task Force**

The Prehn family and NoCapX 2020 requested appointment of an advisory task force. The Commission has the authority to appoint an advisory task force under Minn. Stat. § 216E.08 and Minn. R. 7850.3600.

EERA recommended that the Commission not appoint an advisory task force at this time. In its reasoning, EERA stated that a task force is best suited for evaluating defined geographic locations and impacts. Since this Project is 150 miles in length and has the potential for widely distributed potential impacts, EERA argued it is not a good fit for a task force. Additionally, EERA stated that Xcel has previously considered and rejected numerous route alternatives. EERA argued these processes are potentially responsive to known or anticipated impacts and could be considered in the EIS as a better means of addressing impacts than a task force.

The Commission agrees with EERA that an advisory task force would not provide an effective method for developing the record in this instance. It is unclear how appointing a task force at this juncture would aid the Commission's identification and evaluation of routes and possible mitigation measures. The Commission is persuaded that the full review process provides interested persons full and comprehensive opportunities to identify concerns and to propose alternative route segments, including through the EIS scoping meetings and associated comment period, the draft EIS meetings and associated comment periods, and the public hearings and associated comment periods.

### **IV. Environmental Review and Joint Proceedings**

Under Minn. Stat. § 216B.243, subd. 4, and Minn. R. 7849.1900, subp. 4, the Commission may approve joint proceedings for CN and route permit applications where a joint hearing is feasible, more efficient, and may further the public interest. Additionally, under Minn. R. 7849.1900, subp. 2, an Environmental Impact Statement (EIS) may be prepared in certain circumstances in lieu of the environmental report required under Minn. R. 7849.1200.

All commenters who addressed the question supported joint proceedings for the certificate of need and route permit applications, including joint hearings and environmental review. Commenters agreed that joint proceedings would promote efficiency and avoid confusion that could be caused by holding multiple public meetings and hearings about the same project in two different dockets.

The Commission agrees with the parties and will therefore approve joint public meetings, joint public hearings, and combined environmental review of the certificate of need and route permit applications, including preparation of an EIS in lieu of an environmental report under Minn. R. 7849.1900, subp. 2.

## **V. Jurisdiction and Referral for Contested Case Proceedings**

The Commission's decision accepting the application as complete is as to form only and implies no judgment on the merits of the application. Consistent with the full permitting process set forth under Minn. Stat. § 216E.03, the Commission will refer the matter to the OAH for contested case proceedings.

The Administrative Law Judge assigned to this matter will conduct hearings as described in this Notice and submit a Report to the Commission. Following receipt of the Administrative Law Judge's Report, the Commission will proceed to make its final decision in accordance with Minn. Stat. Ch. 14, 216B, and 216E. The Commission requests that the ALJ issue the report no later than May 16, 2025.

## **VI. Issues to be Addressed**

The Commission expects that in the course of this case the parties will develop a full record addressing issues raised that are relevant to the Commission's environmental review and route permit decisions.

## **VII. Procedural Outline**

### **a. Administrative Law Judge**

The Administrative Law Judge assigned to this case is Ann O'Reilly. Her address is as follows: Office of Administrative Hearings, 600 North Robert Street, St. Paul, Minnesota 55101. ### **b. Hearing Procedure**

- *Controlling Statutes and Rules*

Hearings in this matter will be conducted in accordance with the Administrative Procedure Act, Minn. Stat. §§ 14.57-14.62; Minn. R. 1400. 5010-8400; and to the extent they are not superseded by those rules, the Commission's rules of Practice and Procedure, Minn. R. 7829.0100 to 7829.4000. Hearings may be recessed and reset by the ALJ pursuant to Minn. R. 1405.1400 to .2300.

Copies of these rules and statutes may be purchased from the Print Communications Division of the Department of Administration, 660 Olive Street, St. Paul, Minnesota 55155; (651) 297-3000. These rules and statutes also appear on the State of Minnesota's website at [www.revisor.mn.gov/pubs](http://www.revisor.mn.gov/pubs).

The OAH conducts contested case proceedings in accordance with the Minnesota Rules of Professional Conduct and the Professionalism Aspirations adopted by the Minnesota State Bar Association.

- *Right to Counsel and to Present Evidence*

In these proceedings, parties may be represented by counsel, may appear on their own behalf, or may be represented by another person of their choice, unless otherwise prohibited as the unauthorized practice of law. They have the right to present evidence, conduct cross-examination, and make written and oral argument. Under Minn. R. 1405.1300, they may obtain subpoenas to compel the attendance of witnesses and the production of documents.

Parties should bring to the hearing all documents, records, and witnesses necessary to support their positions.

- *Discovery and Informal Disposition*

Any questions regarding discovery under Minn. R. 1400.6700 to 1400.6800 or informal disposition under Minn. R. 1400.5900 should be directed to Scott Ek (651) 201-2255, Minnesota Public Utilities Commission, 121 7<sup>th</sup> Place East, Suite 350, St. Paul, Minnesota, 55101-2147.

- *Protecting Not-Public Data*

State agencies are required by law to keep some data not public. Parties must advise the Administrative Law Judge if not-public data is offered into the record. They should take note that any not-public data admitted into evidence may become public unless a party objects and requests relief under Minn. Stat. § 14.60, subd. 2.

- *Accommodations for Disabilities; Interpreter Services*

At the request of any individual, this agency will make accommodations to ensure that the hearing in this case is accessible. The agency will appoint a qualified neutral interpreter if necessary. Persons must promptly notify the Administrative Law Judge if an interpreter is needed.

- *Scheduling Issues*

The times, dates, and places of evidentiary hearings in this matter will be set by order of the Administrative Law Judge after consultation with the Commission and intervening parties.

- *Notice of Appearance*

Any party intending to appear at the hearing must file a notice of appearance (Attachment A) with the Administrative Law Judge within 20 days of the date of this Notice and Order for Hearing.

- *Sanctions for Non-compliance*

Failure to appear at a prehearing conference, a settlement conference, or the hearing, or failure to comply with any order of the Administrative Law Judge, may result in facts or issues being resolved against the party who fails to appear or comply.

**c. Parties and Intervention**

The current parties to this case are the Applicant and EERA. Other persons wishing to become formal parties must do so pursuant to Minn. R. 1405.0900. Subpart 1 of that rule prescribes the timing and contents of a petition to intervene. Subpart 2 prescribes the timing and content of any objection to the petition, and subpart 3 sets forth the standards for granting, denying, or requiring consolidation of similar petitions.

The hearing process established under Rule Chapter 1405 is designed to facilitate public participation, and persons need not intervene as parties to participate. All public participants have significant procedural rights, including but not limited to, the right to be present throughout the proceeding, to offer direct testimony in oral or written form, to question all persons who testify, and to submit comments to the Administrative Law Judge and the Commission.

Persons who intervene and are granted party status have additional rights and responsibilities, including, but not limited to, the right to object to another’s petition for intervention, the right to submit direct testimony and conduct cross-examination of other parties’ witnesses, and the duty to submit prefiled testimony, comply with discovery requests, produce witnesses, file briefs, and serve all documents on all other parties.

The description of rights in this section is summary in nature, as required by Minn. R. 1405.0500, subpart 1(I), and is not intended to be comprehensive. Interested parties are encouraged to review Chapter 1405 to identify the scope of rights and authority to act given to “persons” or restricted to “parties” under the various provisions of that chapter.

**d. Prehearing Conference**

A prehearing conference will be held on Monday, August 5, 2024, at 10:00a.m., via Microsoft Teams. The Administrative Law Judge will issue an order containing a link participants may use to access the conference.

Persons participating in the prehearing conference should be prepared to discuss time frames, scheduling, discovery procedures, and similar issues. Potential parties are invited to attend the prehearing conference and to file their petitions to intervene as soon as possible.

**VIII. Ex Parte Communications**

Restrictions on *ex parte* communications with Commissioners and reporting requirements regarding such communications with Commission staff apply to this proceeding from the date of this Order. Those restrictions and reporting requirements are set forth in Minn. R. 7845.7300 – 7845.7400, which all parties are urged to consult.

**IX. Delegation of Authority**

Minn. Stat. § 138.665 requires consultation with the State Historic Preservation Office (SHPO) before carrying out any undertaking that will affect certain designated or listed properties. To ensure proper development of the record, the Commission will delegate administrative authority to the Executive Secretary to authorize the Applicant to initiate consultation with SHPO in order



to determine appropriate treatments and to seek ways to avoid and mitigate any adverse effects on designated or listed properties.

### ORDER

1. The Commission hereby accepts the certificate of need permit application as substantially complete and authorizes review using the informal process.
2. The Commission hereby accepts the route permit application as substantially complete and authorizes review under the full permitting process; the Commission refers the matter to the OAH, recommending joint draft EIS public meetings and public hearings and requesting that the ALJ issue their report no later than May 16, 2025.
3. The Commission approves, to the extent practical, joint public meetings, joint public hearings, and combined environmental review of the certificate of need and route permit applications, including preparation of an EIS in lieu of an environmental report pursuant to Minn. R. 7849.1900, subp. 2.
4. The Commission denies the request to establish an advisory task force at this time.
5. The Commission authorizes the Executive Secretary to issue an authorization to the Applicants to initiate consultation with SHPO.
6. This order shall become effective immediately.
