Dairyland Power Cooperative (Dairyland) respectfully submits these reply comments in response to the comments filed during the scoping comment period for the environmental assessment (EA) being prepared by the Department of Commerce, Energy Environmental Review and Analysis (EERA) staff for the proposed Beaver Creek Transmission Line Project in Fillmore County, Minnesota (Project).

One agency, the Minnesota Department of Natural Resources (MDNR), submitted scoping comments during the comment period ending December 3, 2024. No members of the public submitted written scoping comments.

Response to MDNR Scoping Comments

MDNR submitted comments dated December 3, 2024 regarding karst, calcareous fen, lighting, dust control, and wildlife-friendly erosion control.¹ To the extent the EA prepared for this Project evaluates these topics, Dairyland provides additional information and context to inform that analysis. Dairyland appreciates MDNR's comments and looks forward to continued coordination with MDNR.

1. Karst

MDNR recommended including a special permit condition requiring a karst survey plan and the development of a karst contingency plan prior to construction. Dairyland has no objection to karst considerations being studied in the EA, including evaluation of MDNR's proposed special condition as a route permit condition for the Project. To the extent that it is helpful for development of the EA, section 6.6.2 of the Application includes information regarding the

presence of karst features in the vicinity of the Project, as well as potential impacts to, and proposed avoidance and/or minimization measures for, these features.²

2. Calcareous Fen

MDNR recommended including a special permit condition requiring Dairyland to work with MDNR to determine if any impacts to calcareous fen will occur during any phase of the Project, to develop a calcareous fen management plan in coordination with MDNR if the Project is anticipated to impact any calcareous fens.

Dairyland has no objection to the EA addressing the presence of calcareous fens and evaluating ways to mitigate impacts to these areas, including MDNR's proposed special condition being evaluated as a route permit condition for the Project. To the extent that it is helpful for development of the EA, sections 6.6.4.6 and 6.6.7.1 of the Application include information regarding the presence of calcareous fens in the vicinity of the Project, as well as potential impacts to, and proposed avoidance and/or minimization measures for, these features.³

3. <u>Facility Lighting</u>

MDNR recommended including a special permit condition similar to what was imposed in a recent docket regarding facility lighting. However, Dairyland notes that the proposed special condition, and the underlying concern, pertains to lighting at a substation and facilities associated with a substation.⁴ The Project does not include a substation or facilities associated with a substation in Minnesota, and therefore such a special permit condition is not applicable to this Project.

4. Dust Control

MDNR recommended including a special permit condition prohibiting the use of dust control products containing calcium chloride or magnesium chloride. Dairyland has no objection to the EA evaluating this as a route permit condition for the Project.

5. Wildlife-Friendly Erosion Control

MDNR recommended including a special condition related to the use of wildlife-friendly erosion control measures. Dairyland has no objection to this being studied in the EA.
