The Department recommends the Commission **approve** Xcel's proposed Combined Residential Electric Refund Plan and **approve** Xcel's proposed 2024 Combined Gas Customer Deferral Plan.

I. INTRODUCTION

On July 1, 2025, Xcel filed its 2024 Annual True-Up Report and Proposed Refund/Deferral Plans in the current Petition¹. This filing was made pursuant to multiple Commission Orders, including the July 17, 2023 Order in Docket E002/GR-21-630 (which established electric true-up mechanisms for property tax, incentive compensation, capital investments, and net operating loss),² the March 5, 2025 Order in Docket G002/GR-23-413 (which established natural gas true-up mechanisms for property tax, incentive compensation, and credit card fee waivers),³ and the November 26, 2024 Order in Docket Nos. E,G002/M-23-468 and E,G002/M-24-221, among others, which directed Xcel to consolidate future annual true-up reports into a single comprehensive filing each July 1.⁴ This 2024 report is the first consolidated filing, combining what were previously separate annual compliance filings into a single docket.

In the current Petition, Xcel detailed the results of each approved true-up mechanism for the 2024 calendar year, specifically:

- The Electric Utility Property Tax true-up, comparing actual property tax expenses for 2024 to the baseline amounts included in 2024 electric base rates.
- The Natural Gas Utility Property Tax true-up, comparing actual 2024 gas property tax expenses to the baseline in gas base rates.
- The Annual Incentive Compensation Plan (AIP) true-ups for both electric and natural gas, measuring actual incentive payouts against the amounts recovered in base rates.
- The Electric Capital Expenditure true-up, comparing actual 2024 capital-related revenue requirements to those assumed in base rates (one-way refund mechanism).
- The Net Operating Loss (NOL) Deferred Tax Asset true-up for the electric utility under the established NOL agreement tracks differences in deferred tax asset levels and the revenue requirement effect associated with the utilization of deferred tax benefits.

- The Residential Credit Card Fees Waiver true-up for natural gas, tracking the difference between forecast and actual credit card fee costs that are incurred by the Company.
- The U.S. Department of Energy (DOE) Settlement Payment #16 which is not technically an
 approved mechanism, but consistent with past practices, Xcel intends to include any refundable
 DOE settlement amount in the overall customer credit.

The current Petition also includes a Combined Electric Customer Refund Plan and a Combined Natural Gas Customer Deferral Plan summarizing how the various true-up results will be returned to or deferred from customers. The electric plan proposes a one-time bill credit to refund net over-recoveries (as shown in **Table 1**), while the gas plan proposes to defer the net under-recovery (as shown in **Table 2**). Additionally, Xcel provided a proposed customer bill message to accompany the electric refund.

II. PROCEDURAL BACKGROUND

November 26, 2024 The Commission issued an Order approving Xcel Energy's 2023 Annual

Report of Rate Case Approved True-up Mechanisms and Proposed

Electric Refund and Gas Deferral Plans.9

July 1, 2025 Xcel filed the current Petition requesting approval of Xcel Energy's 2024

Annual Report of Rate Case Approved True-up Mechanisms and

Proposed Electric Refund and Gas Deferral Plans.

III. DEPARTMENT ANALYSIS

The Department's review of the Petition focused on: (1) ensuring that the proposed refund and deferral mechanisms are in compliance with applicable Commission Orders and prior practices; and (2) assessing the reasonableness of each true-up calculation. In the following sections, the Department provides a detailed discussion of each component.

A. XCEL'S PROPOSED 2024 COMBINED RESIDENTIAL ELECTRIC CUSTOMER REFUND PLAN

A.1. 2024 Electric Property Tax True-Up

The Commission's July 17, 2023 Order in Xcel's electric rate case (Docket E002/GR-21-630) set a baseline level of property tax expense in rates and approved a true-up mechanism for the multiyear rate plan period. Xcel's 2024 actual property tax expenses (for its total NSP-Minnesota system) were allocated to the Minnesota electric jurisdiction and then compared to the amount built into 2024 rates, after removing taxes recovered through dedicated rider charges. As detailed in the Petition, the result was that actual electric property taxes for Minnesota electric jurisdiction were \$18.345 million less than the amount in base rates. Thus, customers were over-collected by this amount in 2024 and are due a refund. The Department verified that Attachment B of the Company's report shows the rate-case baseline (from the 2021 rate case test year) versus actual 2024 taxes, and the \$18.345 million refund is correctly calculated.

The Company proposes to refund the \$18.345 million to electric customers, with interest, via a one-time credit. The allocation of the refund to customer classes will use the 2024 property tax expense allocation factors. The Department finds this allocation method appropriate, as it returns the over-collected property taxes to classes in proportion to how those costs were originally collected. The

Company plans to accrue interest at the average prime rate from July 2, 2025, until the refund is issued. This complies with the Commission's directive that the prime rate be used for true-up refunds. ¹² **Table 3** below summarizes the Company's estimated property tax electric customer refunds, including an interest amount of \$287,916, based on the assumed prime cost of debt from July to September 2025, at an annual rate of 7.5 percent.

Based on our review, the electric property tax true-up appears reasonable and in accordance with established procedures. Therefore, the Department recommends the Commission approve Xcel's 2024 property tax true-up of \$18,345,096, excluding interest, or \$18,633,012, including interest from July through September 2025.

A.2. 2024 Annual Incentive Plan Compensation True-Up – Electric

In the July 2023 Order, the Commission imposed specific conditions on Xcel's recovery of AIP compensation. The order required Xcel to cap its recovery of annual incentive plan compensation expense at 15 percent of individual base pay and 100 percent of the target payout, cap its cost recovery on the top ten highest-paid officers and employees salaries to \$1.5 million in total, excluded recovery on the annual incentive plan compensation of the top ten highest-paid officers and employees, and also required the Company to provide a calculation of the Minnesota jurisdictional top ten adjustments in future annual incentive compensation filings. The Commission approved a Minnesota jurisdictional annual incentive plan compensation expense recovery amount of \$24.324 million for the 2024 Multi-Year Rate Plan (MYRP). Xcel was also required to file annual compliance reports detailing the operation of its incentive plan under these caps, and to refund any amounts collected in rates but not actually paid or not eligible for recovery. ¹⁴

For 2024, the current Petition indicates that, after applying the caps and exclusions, the recoverable AIP expense for the electric utility was \$15.397 million, versus \$21.915 million¹⁵ included in base rates, and as a result, the over-collection amount of \$6.518 million will be refunded to customers.

The Department reviewed Xcel's Attachments C, D, E, and F, which detail the top ten executive incentive exclusion and provide a summary of incentive compensation paid. We found that Xcel correctly removed the amounts over 15 percent cap of individual base pay and the additional AIP payouts for its top ten highest-paid. The Company provided a calculation of the Minnesota jurisdictional top ten exclusion amount, as required, and this was reflected in the determination of recoverable costs. Regarding the electric AIP refund of \$6.518 million, Xcel plans to include this amount (with interest) in the combined electric refund credit to be issued to customers. **Table 4** below summarizes the Company's estimated AIP electric customer refunds, including an interest amount of \$102,293, based on the assumed prime cost of debt from July to September, 2025, at an annual rate of 7.5 percent.

Based on our review, Xcel's electric AIP true-up for 2024 is compliant with the Commission's incentive compensation recovery requirements, and results in a refund that appropriately returns over-collected amounts to customers. The Department recommends approval of the electric AIP refund in the amount of \$6,517,795, excluding interest, or \$6,620,089, including interest from July through September 2025.

A.3. 2024 Electric Capital Expenditure True-Up

Xcel's electric capital true-up mechanism was established in the 2021 rate case as a one-way refund true-up: if actual capital-related revenue requirements for a given year of the MYRP are less than those embedded in rates, the difference is refunded to customers; if actuals are higher, the Company absorbs the variance. For 2024, as noted, Xcel's actual capital additions and related revenue requirements exceeded the rate case levels. The Company reports that actual 2024 capital additions

were about \$432 million (42.8%) higher than forecast, and the resulting revenue requirement was \$30.4 million (2.0%) higher than authorized. As a result, no capital true-up refund is due for 2024.

The Department reviewed Xcel's supporting schedules (Attachments G, H, I), which detail the calculation of the actual revenue requirement. Xcel provided explanations for major project variances and noted that increased construction work in progress (CWIP), net plant in service, and depreciation drove the higher revenue requirement, partially offset by higher allowance for funds used during construction. These details provide context but do not affect rates at this time because of the one-way nature of the true-up.

Since the Company met its obligation by filing the annual capital compliance report, and since the outcome is that no customer refund is needed, the Department recommends the Commission acknowledge the 2024 capital true-up report and find that Xcel has complied with the capital true-up requirements for the year.

A.4. Regulatory treatment of Net Operating Loss (NOL) Related Deferred Tax Asset (DTA).

The treatment of NOL carryforward-related deferred taxes for Xcel's electric utility is governed by a long-standing agreement first approved by the Commission in Docket E002/GR-10-971. The NOL

Agreement requires Xcel to annually report the balances and utilization of the NOL/DTA and to true up the revenue requirement impact of any differences from rate case projections.²⁰

For 2024, Xcel's report indicates that the actual increase in revenue requirement due to NOL was \$5.900 million, whereas the amount forecasted in final rates for 2024 was \$8.114 million. Because the actual increase was lower, customers paid for more in rates than what actually occurred, creating an over-collection in the amount of \$2.213 million, which Xcel proposes to refund to electric customers.

The Department reviewed the adjustments that Xcel made to the 2024 DTA and resulting NOL Refund. The Company adjusted the 2024 NOL Annual Report for the Prior Return adjustments. These adjustments corrected an overstatement of the DTA in the rate case compared to actual DTA in the NOL report, as a result of the Company's ability to monetize production tax credits (PTCs) earned in 2024, which results in a refund. Xcel shows these corrections on Attachments L and M of the Petition and provides a summary of the 2024 NOL Refund on page 10 of the Petition as shown in **Table 6** below.

The Company proposed to allocate the \$2.248 million NOL refund, including \$34,737 in interest, to customer classes based on the rate base. Residential customers will receive an average credit of about \$0.81 from this NOL refund. **Table 7** below summarizes Xcel's estimated NOL refunds at the U.S prime interest rate for July to September 2025 at 7.5 percent.

The Department concludes that Xcel's proposed 2024 NOL refund plan is reasonable and complies with the required tracking and refund methodology set by the Commission. The Department recommends approval of the \$2,213,328 NOL refund, excluding interest, or \$2,248,065, including interest from July through September 2025.

A.5. DOE Settlement Payment # 16

In March 2023, Xcel and the U.S. Government reached an agreement to extend the 2011 settlement, making the fourth extension, for the recovery of spent fuel storage damages for the three-year period from 2023 through 2025 (Payments #15, 16, and 17). The settlement amounts will be payable in 2024, 2025, and 2026. In the Petition, Xcel reports that it expects to receive DOE #16 in late 2025, but the exact amount and timing were not confirmed by the July 1 filing. The Company states that it plans to include the Minnesota jurisdictional share of DOE #16 in the combined electric refund if the amount is known by the time the refund is implemented.²²

The Department finds this approach reasonable and consistent with past practice. If DOE #16 is included, those funds will be allocated to the customer classes according to the same methodology used in prior DOE refunds, typically nuclear plant capacity and energy allocators. Xcel has indicated those allocators in Table 5 of the Petition as placeholders. In conclusion, the Department supports the inclusion of DOE Settlement #16 funds in the 2024 combined electric refund if timing allows and otherwise returning them as soon as practicable thereafter.

A.6. Xcel's Combined Electric Customer Refund Plan

The Petition outlines a comprehensive plan to combine all the electric-related refund amounts into a single refund per customer class. The components being combined for electric are:

- 2024 Property Tax true-up refund (\$18.345 million),
- 2024 AIP true-up refund (\$6.518 million),
- 2024 Capital Expenditure true-up refund (\$0, as no refund is due),
- 2024 NOL/DTA true-up refund (\$2.213 million), and
- DOE Settlement #16 refund (TBD).

Refunds from Property Tax true-up, AIP true-up, and NOL true-up will accrue interest from July 2, 2025, until the refund is issued. For those requiring interest (except for the DOE Settlement Payment #16), Xcel has used the monthly prime rate in its calculations. All refunds are calculated before interest, and then interest is added when credits are applied. The Company provided Attachment O, which details class-by-class refund factors. In summary, Xcel will calculate a refund factor (in \$/kWh) for each electric customer class by dividing the total refund amount (with interest) for that class by the class's 2024 retail sales (kWh). This approach mirrors how the prior combined refund (for 2022 and 2023 true-ups) was handled, as approved by the Commission.

In conclusion, the Department finds the Combined Electric Refund Plan to be in compliance with applicable Commission Orders and prior practices. As a result, the Department recommends the Commission approve Xcel's Combined Electric Refund Plan, which is estimated to be a \$27.1 million total refund (plus interest), and estimated to be a \$9.89 refund for the average residential customer.

B. XCEL'S PROPOSED 2024 COMBINED GAS CUSTOMER DEFERRAL PLAN

B.1. Natural Gas Property Tax True-Up

The Commission's March 5, 2025 Order in Xcel's most recent gas rate case (Docket G002/GR-23-413) set a baseline for property taxes in gas rates and implemented a property tax true-up mechanism. For 2024, Xcel's Minnesota gas jurisdiction property tax expenses were \$2.932 million higher than the amount in base rates shown in **Table 8** below:

In the current Petition, Xcel proposes to combine the 2024 gas property tax shortfall with the results of other gas true-ups (AIP and Credit Card Fees Waiver) to determine an overall net refund or surcharge position for the gas utility. The Department has verified the accuracy of the \$2.932 million calculation and finds that the Company's method is in compliance with Commission Orders. As a result, the Department recommends the Commission accept the gas property tax true-up.

B.2. 2024 AIP Compensation True-Up – Natural Gas

For 2024, Xcel's Minnesota natural gas jurisdiction AIP actual expense was approximately \$1.6 million, versus \$1.5 million in rates. After applying the 15% cap, the eligible incentive expense for recovery was reduced, such that the Company actually over-collected \$94,656 relative to what it was permitted to recover. Acel proposes to combine this \$94,656 over-collection with the gas deferral. Specifically, the \$94,656 is added to the other gas refund items to offset the \$2.932 million property tax shortfall.

The Department finds this approach reasonable and consistent with the Commission Orders that gas true-up results can be netted for practical implementation. The Department verified the \$94,656 calculation and found it reasonable. As a result, the Department recommends the Commission accept the gas AIP true-up and combine the \$94,656 into the combined gas deferral as proposed.

B.3. Residential Credit Card Fees Waiver True-Up

As part of the 2021 gas rate case, the Commission approved a unanimous Settlement Agreement where parties agreed that Xcel would begin waiving credit card fees for residential ratepayers

beginning January 1, 2024.²⁵ In addition, the 2023 Order and the March 2025 Order required the Company to make annual compliance filings in May, providing the actual credit card costs incurred by the Company, and then to include the difference as part of Xcel's annual true-up process.

On May 23, 2025, Xcel submitted a filing in compliance with the Commission's April 13, 2023 Order in Docket No. G002/GR-21-678 and the March 5, 2025 Order in Docket G002/GR-21-413. For 2024, Xcel forecasted spending \$1,691,988 on credit card fees for gas customers, assuming both one-time and Auto Pay credit card payments would be available. However, a delay in adding credit card support to Auto Pay resulted in only one-time payments incurring fees, which led to actual costs of just \$303,015. This difference (\$1,388,973) does not accrue interest and will be refunded to customers under the terms of the true-up mechanism. The Company indicates that because this item is specific to the residential class, the refund is allocated 100% to the residential gas class as shown in **Table 9** below:

As part of the Combined Natural Gas Deferral Plan (discussed below), this \$1.389 million refund is netted against the \$2.932 million property tax deficit, substantially reducing the net amount deferred. The Department finds this approach is reasonable and in compliance with the Commission Orders. As a result, the Department recommends the Commission accept Xcel's Credit Card Fees Waiver true-up.

B.4. Xcel's Combined Natural Gas Customer Deferral Plan

For the natural gas true-up, 2024 resulted in a net under-collection when all true-up items are combined. As detailed earlier: a \$2.932 million under-collection in property taxes was partially offset by a \$94,656 over-collection in AIP and a \$1.389 million over-collection in credit card fees. Additionally, a residual deferral of \$0.168 million from prior years was carried into 2024. In sum, the net outcome is a \$1.616 million under-collection (deferral) for 2024. The Company states that all components of the

net natural gas deferral are allocated to class separately, after which the deferrals and refunds owed to each class are combined.²⁸ After combining these, the residential class has a net (\$0.44) per customer deferred balance. Because this is a net deferral owed by customers, there will be no credits on customer bills for gas at this time.

The Department finds that Xcel's Combined Gas Deferral Plan properly nets all relevant items and is in compliance with Commission Orders. As a result, the Department recommends the Commission accept Xcel's Combined Gas Deferral Plan and approve the deferral amount of (\$1.616,608).

C. CUSTOMER BILL MESSAGE

Xcel plans to issue the combined electric refund as a one-time bill credit in either Q3 or Q4 of 2025. The combined refund will appear on bills as a single line item "Combined Elec. Refund CR." The Company proposes a draft bill message with two options (one with the DOE refund included and one without).

Xcel states that they will work with the Commission's Consumer Affairs Office to finalize the bill message in advance of implementing the 2024 Electric Combined Refund Plan. The Company also plans to file a compliance report summarizing the results of the combined refund that will be filed within 30 days of completing the refund payments to customers.

The Department finds the customer bill message for the 2024 combined refund to be reasonable and consistent with the 2023 combined refund (November 2024 Order). The Department considers a compliance report by Xcel 30 days after completion of the refund payments to customers to be reasonable.

IV. DEPARTMENT RECOMMENDATIONS

After reviewing Xcel's compliance report, the Department recommends the Commission take the following actions:

- A. XCEL'S PROPOSED 2024 COMBINED RESIDENTIAL ELECTRIC CUSTOMER REFUND PLAN
 - Approve the Company's proposed 2024 Property Tax true-up refund in the amount of \$18,633,012, including interest from July through September 2025, for electric customers;
 - Approve the Company's proposed 2024 AIP true-up refund in the amount of \$6,620,089, including interest from July through September 2025, for electric customers;
 - Accept the Company's 2024 Electric Capital Expenditure true-up report;
 - Approve the Company's proposed 2024 NOL-related Deferred Tax Asset true-up refund in the amount of \$2,248,065, including interest from July through September 2025, for electric customers;
 - Accept the Company's proposed DOE Settlement Payment # 16 refund plan;

- Authorize the Company to apply, on a monthly basis, the average monthly prime interest
 rate to its Property Tax refund, AIP refund, and NOL-related Deferred Tax Asset refund
 through the month immediately preceding the billing cycle in which the Company issues
 refunds to ratepayers;
- Approve the Company's proposed plan to combine Property Tax refund, AIP refund, and NOL-related Deferred Tax Asset refund, as long as interest on refund amounts accrues until the excess rate recoveries are refunded;
- Require Xcel to include its finalized refund message on customer bills to alert ratepayers to the reason for the refund(s); and
- Require Xcel to file a compliance report summarizing the results of the combined refund within 30 days of completing the refund process.

B. XCEL'S PROPOSED 2024 COMBINED GAS CUSTOMER DEFERRAL PLAN

- Approve the Company's proposed 2024 Property Tax true-up deferral in the amount of (\$2,932,415) for gas customers;
- Approve the Company's proposed 2024 AIP true-up refund in the amount of \$94,656 for gas customers;
- Approve the Company's proposed 2024 Credit Card Fees Waiver refund in the amount of \$1,388,973 for gas customers;
- Approve the Company's proposal to combine the 2024 Property Tax deferral, AIP gas refund, and Credit Card Fees Waiver refund.
