RE: Addendum to Comments of the Minnesota Department of Commerce,

Division of Energy ResourcesDocket No. T6133/RP-13-1165

Dear Dr. Haar:

On April 21, 2014, the Minnesota Department of Commerce, Division of Energy Resources (DOC or the Department) submitted its initial comments on Minnesota Municipal Power Agency's (MMPA or the Agency) 2014 Integrated Resource Plan (IRP).

In discussions with the Department since then, MMPA raised concerns about the rate comparison on pages 19-21 of the Department's comments. MMPA correctly noted that the Department's analysis was based on information from the Minnesota Utility Data Book and that information includes the distribution rates that MMPA's members charge to their residents/ratepayers and as such reflects more than MMPA's generation and transmission costs. The Department's intention was to focus on rate impacts for retail ratepayers, but acknowledges that, since MMPA does not control the rates that its municipal members charge, including that component of the rates charged to retail ratepayers reflects more than the issues in the current proceeding.

Further, as noted in our comments, the Commission's role relative to MMPA's IRP is advisory; MMPA and its members retain the authority to determine rate levels and select generation options. The Department's discussion about current rates and the impact that the Agency's proposed expansion plan may have on those rates was intended to be advisory only, for MMPA to use or not use as may be appropriate.

In our discussions, MMPA also asked for clarification of our recommendation that in the future the Agency "analyze a range of possible fuel and capital costs, along with a range of environmental costs." To be more specific, the Department recommends that MMPA analyze the nine scenarios it lists on page 41 of its initial filing under three forecasts—low, base, and high. This improvement will result in the analysis of 27 different scenarios.

The Department is available to answer any questions that the Commission may have.
