**Amendment No. 2
to Electric Service Agreement
Between Northern States Power Company
and Terving Seeds Inc.**

THIS Amendment No. 2, is made this 9 day of March, 2015, between Northern States Power Company, a Minnesota corporation and wholly owned subsidiary of Xcel Energy Inc. ("Xcel Energy" or "Utility") and Terving Seeds Inc. ("QF")

WHEREAS Xcel Energy and QF entered into an Amendment No. 1 to Electric Service Agreement ("Agreement") dated December 19, 2014, by which Xcel Energy provides electric service to QF; and,

WHEREAS QF desires to further amend the Agreement and to make a different selection under that Agreement so that it selects the simultaneous purchase and sale under the A51 tariff instead of the time-of-day purchase rates under the A52 tariff;

NOW, THEREFORE, the parties hereby amend the Agreement with the following terms and conditions:

AGREEMENTS

Paragraph 2 on pages 1-2 of Amendment No. 1 of the Agreement is hereby amended so that as of the effective date of the Amendment No. 1 of the Agreement (as determined by the Commission) the Utility will buy electricity from the QF pursuant to the simultaneous purchase and sale billing rate under the A51 Tariff. The prior QF designation in Amendment No. 1 of the Agreement to have the Utility buy electricity under the Time-of-Purchase rates under the A52 Tariff does not apply.

This Amendment No. 2 becomes effective as soon as it is approved by the Commission and the parties have signed it. All other terms of Amendment No. 1 of the Agreement remain unchanged.

THE QF AND THE UTILITY HAVE READ THIS AMENDMENT NO. 2 AND AGREE TO BE BOUND BY ITS TERMS. AS EVIDENCE OF THEIR AGREEMENT, THEY HAVE EACH SIGNED THIS AMENDMENT NO. 2 BELOW ON THE DATE WRITTEN AT THE BEGINNING OF THIS AMENDMENT NO. 2.
