Under Minn. Stat. § 216B.2425, utilities are required to submit a Transmission Projects Report to the Public Utilities Commission by November 1 every odd numbered year. The next report is due November 1, 2019.

Minn. R. 7848.1900 requires utilities to submit to the Commission by June 1 of the year the Biennial Report is due a proposed notice plan for any transmission lines for which certification will be sought as part of the biennial reporting process.

This letter confirms that the Minnesota Transmission Owners do not anticipate that there will be any transmission certification requests included with the 2019 Biennial Report. Accordingly, no notice plans will be filed by June 1, 2019.
