RE: REPLY COMMENTS ON NOTICE PLAN

In the Matter of the Application for a Certificate of Need for the Bison to Alexandria Second Circuit 345 kV Transmission Line Project

DOCKET NO. E002, ET2, E015, E017, ET6135/CN-25-116

Dear Ms. Bergman:

Northern States Power Company, doing business as Xcel Energy, Great River Energy, Minnesota Power, Otter Tail Power Company, and Western Minnesota Municipal Power Agency (together, the Utilities) respectfully submit these reply comments to the Minnesota Public Utilities Commission (Commission) concerning the Notice Plan filed by the Utilities on August 15, 2025 for the Bison-Alexandria 345 kilovolt (kV) transmission line project (Project). The Project involves adding a new 345 kV transmission circuit on existing transmission line structures from the existing Bison Substation near Fargo, North Dakota to the existing Alexandria Substation near Alexandria, Minnesota. The existing 345 kV structures were previously permitted and constructed as double-circuit capable as part of the Fargo – St. Cloud 345 kV Transmission Project (Fargo Project).¹

Initial comments regarding the Notice Plan were filed by the Department of Commerce (Department)² and No CapX 2020.³ The Utilities respond to these commenters in turn below.

After careful review of the Notice Plan against the Minnesota rule requirements, the Department recommends approval of the Notice Plan with three minor modifications: (1) add Evansville and Brandon townships to the list of local government units; (2) use the name "Ojibwe" rather than "Chippewa" in all future mailings, unless otherwise directed by tribal representatives; and (3) revise the direct mail and newspaper notices to state that the Commission will prepare the environmental report. The Utilities appreciate the Department's thorough review of their proposed Notice Plan and agree with the Department's three proposed modifications.

No CapX 2020

In its August 28, 2025 comments, No CapX 2020 recommends two modifications to the proposed Notice Plan. First, No CapX 2020 recommends that notice be provided, as part of the Notice Plan, to all the "intervenors and commenters" who participated in the route permit proceeding for the Fargo Project. The Utilities do not believe that adding this additional group to the proposed Notice Plan would be beneficial. First, to the extent that those that participated in route permit proceeding for the Fargo Project still live in the area, they will be provided notice through the proposed Notice Plan as the Utilities will send direct mail notice to all landowners and mailing addresses within 0.5 miles of the Fargo Project's existing centerline. In addition, to the extent that these persons live outside this notice area, newspaper notices will run in local papers and the Star Tribune informing interested persons of the proposed Project. Through these new notices, interested parties will be able to be informed of the new Project and provided information about how to sign up for future notices.⁴ Next, the route permit proceeding for the Fargo Project concluded over 14 years ago and the contact information for many of the parties on those prior service lists are likely out of date. The Utilities therefore request that No CapX 2020's recommendation to add the "intervenors and commenters" who participated in the route permit proceeding for the Fargo Project to this Project's Notice Plan be rejected.

Next, No CapX 2020 recommends that the Commission deny the Utilities' request for a variance of Minn. R. 7829.2500, subp. 5 that requires an applicant to publish notice of the filing of the Certificate of Need application in a newspaper of general circulation throughout the state. No CapX 2020 opposes this variance because Certificate of Need

proceedings "receive too little attention." As stated in the Utilities' Notice Plan petition, the Utilities are not requesting this variance to limit the amount of notice provided but rather are requesting the variance due to the fact that the newspaper notice published as part of the Notice Plan could be published as soon as two weeks prior to the filing of the Certificate of Need application. Providing two different newspaper notices about the Project within a two week period is potentially confusing to interested persons and has limited value. The Utilities continue to request that the Commission grant the requested variance to Minn. R. 7829.2500, subp. 5.
