Northern States Power Company, doing business as Xcel Energy, along with Great River Energy, Minnesota Power, Otter Tail Power Company, and Western Minnesota Municipal Power Agency (collectively, the Applicants) respectfully submit this response to the written comments filed by the January 8, 2024, deadline regarding the scope of the environmental assessment (EA) for the Big Stone South to Alexandria to Big Oaks 345 kilovolt (kV) Transmission Project (Project)¹ that is being prepared by Minnesota Department of Commerce, Energy Environmental Review and Analysis (DOC-EERA). Written comments were filed by the Minnesota Department of Natural Resources (MnDNR), the Minnesota Department of Transportation (MnDOT), Swift County, the International Brotherhood of Electrical Workers (IBEW) Local Union 160, and the general public. In these response comments, the Applicants respond to the MnDNR's proposed route alternatives and address the comments and recommendations made by MnDNR, MnDOT, Swift County, and members of the general public.

### A. Response to MnDNR Comments

MnDNR's January 8, 2024 comments identified three new route alternatives for the Project's crossing of the Mississippi River, as well as several potential impacts, mitigation measures, and route permit conditions for study in the EA. The Applicants address MnDNR's comments below.

### 1. Proposed Route Alternatives for the Mississippi River Crossing

The majority of the Applicants' Proposed Route for the new 345 kV transmission line from the Alexandria Substation to the Big Oaks Substation (the Eastern Segment) follows existing transmission line right-of-way as this segment of the Project involves placing a new 345 kV circuit on existing double-circuit capable transmission structures. At four locations, the Proposed Route for the Eastern Segment deviates from the existing transmission line right-of-way. One of these locations is at the Mississippi River where a new crossing of the river is required to connect the new 345 kV circuit to the Big Oaks Substation. MnDNR proposes three new route alternatives for the Project's crossing of the Mississippi River: MnDNR Mississippi River Crossing Options 1, 2, and 3. These three river crossing options are shown on **Attachment A, Figure 1**. The Applicants appreciate the MnDNR providing these river crossing options for consideration in the EA. While the Applicants do not object to these new river crossing options being evaluated in the EA, there are refinements that should be considered to the MnDNR's proposed alignments to ensure that they can feasibly be constructed, operated, and maintained. Each of these minor alignment shifts would be within MnDNR's recommended 1500-foot route width.

The Applicants would recommend that the alignment for the MnDNR Mississippi River Crossing Option 1 be shifted south after it crosses the Mississippi River to avoid a new University of Minnesota research building that is currently under construction and to provide adequate clearances between the proposed 345 kV transmission line and existing 345 kV transmission lines in the area. This revised alignment to Option 1 is shown in **Attachment A, Figures 2a and 2b**.

The Applicants would further recommend that the alignment for MnDNR Mississippi River Crossing Option 2 be shifted east to avoid an existing pivot irrigation system located north of Interstate 94. This revised alignment to Option 2 is shown in **Attachment A, Figure 3**.

After MnDNR Mississippi River Crossing Option 3 crosses the Mississippi River, the Applicants recommend that the alignment be shifted south towards the Mississippi River to provide sufficient clearances between the proposed 345 kV transmission line and existing 345 kV transmission lines in this area. The Applicants note, however; that moving this alignment to the south will result in impacts to sites of biodiversity significance and native plant communities. This revised alignment to Option 3 is shown in **Attachment A, Figure 4**.

The Applicants also believe that it would be helpful to provide additional information regarding potential impacts of the Applicants' two proposed river crossing alternatives and the MnDNR's three proposed river crossing alternatives to aid in the development of the EA.

In the Route Permit Application, the Applicants included two route alternatives for the Mississippi River crossing: the Western Crossing Option and the Eastern Crossing Option. In developing these two route alternatives, the Applicants sought to maximize the use of Xcel Energy-owned land to avoid impacts to other landowners and residences in this area. The Applicants' Mississippi River crossing options do not require easements on other privately-owned property and there are no residences within 500 feet of either the Western Crossing Option or the Eastern Crossing Option. In contrast, MnDNR Mississippi River Crossing Options 2 and 3 would require acquisition of new right-of-way from private landowners and locating the Project closer to residences. The proposed centerline for MnDNR Mississippi River Crossing Option 2 is within 500 feet of two residences and is within 335 feet of the nearest residence. The proposed centerline for MnDNR Mississippi River Crossing Option 3 is within 500 feet of seven residences and is within 118 feet of the nearest residence. MnDNR Mississippi River Crossing Options 2 and 3 would also impact privately-owned agricultural lands and require acquisition of new easements from 2 (Option 2) to 8 (Option 3) new landowners.

In developing route alternatives for the Mississippi River crossing, the Applicants also sought to minimize the overall length of these routes in order to reduce potential impacts and costs. MnDNR Mississippi River Crossing Option 3 is longer than the Applicants' two proposed Mississippi River crossing options. Applicants' Western Crossing Option is 0.7 miles long and Applicants' Eastern Crossing Option is 2.1 miles long. In contrast, the MnDNR Mississippi River Crossing Option 3 is 3.9 miles long. The longer length of MnDNR Mississippi River Crossing Option 3 requires more foundations and structures resulting in increased impacts and costs as compared to

Applicants' two river crossing alternatives. Table 1 below provides a comparison of the potential impacts of Applicants' and MnDNR's proposed Mississippi River crossing options. The impacts for MnDNR's crossing options are based on the revised alignments shown in **Attachment A**.

Lastly, in addition to the above items being included in the scope of the EA, the Applicants recommend that transmission structure configuration alternatives be explored to reduce impacts to both the river and flyway corridor.

## 2. Ecologically Significant Areas and Calcareous Fens

The Applicants agree with MnDNR's recommendation that the EA should address the presence of ecologically significant areas and calcareous fens and evaluate ways to mitigate impacts to these areas. To the extent that it is helpful for development of the

EA, the Route Permit Application includes information on Sites of Biodiversity Significance throughout Chapter 6 and on calcareous fens in section 6.6.3.2.4.

#### 3. State-Listed Threatened and Endangered Plants and Animals

The Applicants agree with the MnDNR that potential impacts to state-listed plant and animal species should be evaluated in the EA along with measures to avoid or minimize these impacts. In section 6.6.7.2 of the Route Permit Application, the Applicants included information regarding potential impacts to, and mitigation measures for, these state-listed plant and animals. The Applicants will continue to work with the MnDNR to avoid or minimize adverse impacts to these state-protected species and will implement as appropriate, species-specific best management practices (BMPs) if Project activities will take place during the respective species active season.

### 4. Facility Lighting

The MnDNR recommends that the EA include a discussion of measures to mitigate lighting impacts at the new and existing substations for the Project. The Applicants support such an evaluation so long as any recommended mitigation measures acknowledge and are subject to any applicable North American Electric Reliability Corporation, National Electric Safety Code, and other applicable safety and security requirements at these substations.

#### 5. Dust Control

The MnDNR recommends that the Applicants avoid the use of dust control products that contain chlorides. The Applicants support the EA evaluating this as a route permit condition for the Project.

## 6. Wildlife-Friendly Erosion Control

The MnDNR recommends that any erosion control blankets used for the Project should be limited to bio-netting or natural netting types as opposed to those containing plastic. The Applicants support the EA evaluating this as a route permit condition for the Project.

## B. Response to MnDOT Comments

In comments dated January 8, 2024, MnDOT described several recommendations related to construction practices and continued MnDOT coordination during and after

construction of the Project. The Applicants appreciate MnDOT's ongoing coordination regarding this Project and commit to developing Traffic Control Plans and other permit applications cited in MnDOT's recommendations.

### C. Response to IBEW Local 160 Comments

In comments dated January 8, 2024, the IBEW Local 160 expressed support for the Project noting that the Project is needed to bolster the grid in light of changes to the generation mix. The Applicants appreciate IBEW Local 160's comments and agree with their assessment of the need for this Project.

### D. Response to Swift County Comments

In comments dated January 8, 2024, Swift County outlined several potential impacts that should be evaluated in the EA. The Applicants support the EA evaluating the potential impacts identified by Swift County.

### E. Response to General Public Comments

Six landowners or members of the public submitted comments during the scoping period but none of these comments proposed a route alternative for consideration in the EA. Many of these comments identified potential impacts and mitigation measures that should be evaluated in the EA. Based on the Applicant's understanding, these impacts and mitigation measures, for the most part, are usually included in the scope of an EA. The Applicants note that the comments filed by Carol Overland reiterate many of the same items that she raised in her October 18, 2023 comments on the completeness of the Certificate of Need and Route Permit applications. The Applicants previously responded to these comments from Ms. Overland in their October 25, 2023 reply comments.
















