**STATEMENT REGARDING THE JUSTIFICATION FOR EXCISING  
TRADE SECRET INFORMATION**

Pursuant to the Commission's September 1, 1999 Revised Procedures for Handling Trade Secret and Privileged Data in furtherance of the intent of Minn. Stat. § 13.37 and Minn. Rule 7829.0500, the Minnesota Municipal Power Agency has designated a portion of its **Renewable Energy Certificate (REC) Retirement and Biennial REO-RES Compliance Report for Renewable Energy Standards (RES) and Green Pricing Programs** as trade secret data.

The Minnesota Municipal Power Agency has removed certain information from the report to prevent disclosure in order to protect economic value of the information to the Minnesota Municipal Power Agency. The Minnesota Municipal Power Agency engages in the purchasing and selling of RECs in a competitive market. Accordingly, the Minnesota Municipal Power Agency considers certain aspects of those trades, such as pricing, as having economic value from not being generally known to or readily ascertainable by competitors, as well as potential suppliers and buyers, who might derive economic value from its disclosure. Therefore, the Minnesota Municipal Power Agency has excised this information from any applicable public document in the report.

In addition to owning, operating and developing its own resources, MMPA purchased RECs during the 2012-2013 period. MMPA also signed three (3) wind PPAs that total 138 MW. Some of these PPAs are projected to deliver renewable energy to MMPA starting in 2014. With current inventory, resources and contracted market purchases, MMPA projects that it can maintain compliance through 2021, excluding the 138 MW PPAs.
