

NOTICE OF COMMENT PERIOD ON AMENDED DECOMMISSIONING PLAN

In the Matter of the Application of Hayward Solar LLC for a Certificate of Need and Site Permit under the Alternative Permitting Process for the up to 150 MW Hayward Solar Project in Freeborn County

PLEASE TAKE NOTICE that the Commission is seeking comments on whether Hayward Solar LLC's (Hayward Solar, applicant) Amended Decommissioning Plan (ADP) satisfies the Commission's Site Permit requirements, and whether any changes or additional requirements should be made to the applicant's plan.

Hayward Solar applied for a Certificate of Need (CN) and a Site Permit to construct and operate a 150-megawatt (MW) solar energy generation facility in Freeborn County (Project) in May 2021. Hayward Solar amended the applications in October 2021. In its order on the completeness of the applications the Commission required Hayward Solar to file an Amended Decommissioning Plan prior to the Public Hearings for the Project. The Department of Commerce Energy Environmental Review and Analysis unit filed its Environmental Assessment of the Project on March 2, 2022.

On March 28th and 29th, 2022, public hearings were held on the applications. On July 29, 2022, Hayward Solar filed an ADP. Because the ADP was not filed prior to the public hearings, the content of the ADP was not available for public review and comment. This comment period is being established to provide the opportunity for comments specific to the ADP itself.

Comments received after the close of the comment period may or may not be considered by the Commission.

Topics Open for Comment:

Does the Amended Decommissioning Plan:

- Provide an itemized breakdown of the costs of decommissioning all project components, including labor and equipment?
- Provide cost estimates for the removal of solar panels, racks, underground collection cables, access roads, transformers, substations, and other components?
- Provide information identifying all surety and financial securities established for decommissioning and site restoration?
- Should there be any additional items or changes to the plan?

Filing Requirements: Utilities, telecommunications carriers, official parties, and state agencies are **required** to electronically file documents using the Commission's electronic filing system (eFiling).
