Dear Mr. Seuffert:

The Office of the Minnesota Attorney General – Residential Utilities Division appreciates this opportunity to respond to the Findings of Fact, Conclusions of Law, and Recommendations issued by Judge Middendorf on March 13, 2024. The Report is thorough, well-reasoned, and clear in its conclusions, and the Commission should adopt it.

Throughout this docket, some of CenturyLink's most landline-dependent telephone customers have reported repeated outages, emergency service disruptions, and other serious performance issues with their wireline telephone service. The Report documents the depth and breadth of CenturyLink customers' wireline telephone service quality issues, and CenturyLink's systemic failures to address them. These pervasive failures—along with expert testimony, photographs, and other record evidence captured in the Report—demonstrate that CenturyLink is failing to meet the standard of service the Commission's rules require a carrier of last resort to provide. ¹

Noting that the Commission has repeatedly resisted CenturyLink's call to extinguish the service quality rules in recent dockets, the Report reaffirms the Commission's conclusion that the service quality rules remain vital to protect the "health and safety of people, particularly those

more reliant on landline service."² The Report then recommends a series of actions CenturyLink should take to bring its provision of service into compliance with the Commission's rules.

The OAG strongly encourages the Commission to adopt Judge Middendorf's findings and recommendations to protect Minnesotans. CenturyLink is the carrier of last resort for some of Minnesota's most wireline telephone service dependent citizens. Through its rules, the Commission has outlined a standard of service every Minnesotan can expect to receive from its telephone carrier. The Report clearly documents CenturyLink's failure to meet this standard and recommends concrete steps to restore appropriate services to Minnesotans who rely on a landline to call 9-1-1, communicate with family and friends, and other communication needs.
