Dear Mr. Wolf:

In its Comments to the Commission in the above-referenced document, the Minnesota Department of Commerce, Division of Energy Resources (Department) incorrectly stated twice that MERC had requested a July 29, 2015 implementation date for the proposed agreement. MERC requested a June 29, 2015 implementation date. The Department also included an incorrect docket number in Attachment B. The Department's proposed corrections are as follows:

- On page 1 of the Comments, the sentence that currently reads: "MERC proposed an implementation date for the new agreement of July 29, 2015" should be changed to; "MERC proposed an implementation date of June 29, 2015."
- On page 8, the sentence that currently reads: "The Department recommends that the Commission approve MERC's request, approve the implementation date of July 29, 2015 and terminate the Integrys Affiliated Interest Agreement approved in Docket No. G-011/AI-13-623," should be changed to read: "The Department recommends that the Commission approve MERC's request, approve the implementation date of June 29, 2015 and terminate the Integrys Affiliated Interest Agreement approved in Docket No. G-011/AI-13-623."
- On page 1 of Attachment B, the title to Table 1 currently reads: "Table 1 – Changes to Tax Allocation AIA Included in Docket No. G001/AI-15-704," should be changed to: "Table 1 – Changed to Tax Allocation AIA Included in Docket No. G-011/AI-15-705."
- On page 1 of the Comments, the first line in Section I should read "Pursuant to Minn. Stat. §216B.48, Minn. R. 7825.2200,<sup>1</sup> . . ." rather than "Pursuant to Minn. Stat. §216B.48, Minn. R. 7825.2200,1 . . .".
