**In the Matter of the Application of Dairyland Power Cooperative for a Certificate of Need and Route Permit for the Wabasha Relocation 161 kV Transmission Line Project in Wabasha County**

**PUC Docket Number:** ET-3/CN-23-504 (Certificate of Need)

**PROCEDURAL HISTORY**

On March 27, 2024, Dairyland Power Cooperative filed a Certificate of Need application for their Wabasha Relocation 161 kV Transmission Line Project.

By June 12, 2024, comments had been received by Elizabeth and Ron Sanders, Angie Murphy, and the Minnesota Department of Commerce, Energy Environmental Review and Analysis (EERA) unit.

On June 5, 2024, Dairyland Power Cooperative filed a request to withdraw its Certificate of Need application due to the passage of recent legislation that exempts relocation of an existing high voltage transmission line to new right-of-way, provided that any new structures that are installed are not designed for and capable of operation at higher voltage.

No comments objecting to the withdrawal were received by the Commission.

**PLEASE TAKE NOTICE** that under Minn. Rules, Part 7829.0430, subp. 1, the Minnesota Public Utilities Commission has delegated to its Executive Secretary the authority to approve the withdrawal of a filing if the following conditions are met:

1. The party that submitted the filing has requested that the filing be withdrawn and has served notice on the persons listed on the official service list;
2. No person has expressed opposition to the withdrawal of the filing within 14 days of service of the notice; and
3. No commissioner or commission staff person has identified a reason that the matter should not be withdrawn.

Based on the review by the Executive Secretary and assigned Commission staff, the above-named petitioner's request for withdrawal of its filing under this docket satisfies the above noted criteria. Therefore, this request for withdrawal of the filing is hereby approved.
