Dear Mr. Seuffert:

Northern States Power Company, doing business as Xcel Energy (Company), submits this letter in compliance with the Minnesota Public Utilities Commission's January 13, 2025 Order in Docket No. E002/M-24-27. Order Point No. 23 requires the Company to make a filing in the above referenced dockets "...detailing its current disconnection policies and practices...within 20 days of the Order."

In fulfillment of that Order Point, on January 31 we filed a document entitled *Minnesota Disconnection Process*. Citizens Utility Board of Minnesota brought to our attention that this document was in their view unclear on the distinction the Company makes, when discussing payment plans with individual customers, between household financial circumstances and extenuating circumstances.

Xcel Energy negotiates payment agreement terms, including down payment amounts and length of arrangements, individually with each customer. We consider both household financial circumstances and extenuating circumstances in those conversations. The reduced down payments, as described in Order Point 26 of the January 13, 2025 Order in this docket and shown in the "Graduated Down Payment Structure for Payment Plans" table of Attachment A, serve as a guide for those conversations; however, lower down payments may be offered on a case-by-case basis

in consideration of both household financial circumstances and extenuating circumstances.

We note that this is not a change in practice; however, we acknowledge the January 31 version of our *Minnesota Disconnection Process* was not entirely clear. The attached, revised version replaces our January 31 filing.

This revised document has also been posted to Xcel Energy's website, consistent with Order Point 22 of the Commission's January 13, 2025 Order in Docket No. E002/M-24-27. We have posted the document to both the Manage Your Bill page,¹ and the Pay Arrangements page,² as the most intuitive locations for a customer wishing to understand the disconnection process and options to avoid disconnection.

Minnesota Disconnection Process

Minnesota Residential:

Disconnection is a last resort, only occurring after a process during which Xcel Energy works with customers who are unable to pay their full balance or full disconnect balance to agree on a payment arrangement that works for them. We also refer customers to various forms of energy assistance.

Notice. The disconnection/shut-off notice due date is ten business days after the Disconnection Warning Statement during both Non-Cold Weather Rule (CWR) (May 1 – September 30) and Cold Weather Rule (CWR) (October 1 - April 30).

Payment thresholds. Disconnect notices will only be mailed out once a customer's past due balance reaches \$180. Customers are not subject to disconnection until the balance reaches at least \$300.

Communication channels. For customers who have given the Company permission through their preferred notification channels, we will attempt two methods of electronic communication to reach customers prior to disconnection. This can include text and/or email, though only if the customer has given the Company permission to use those channels. We send disconnection notices to both service and mailing addresses, if different.

Payment arrangements. Xcel Energy offers two different types of payment arrangements: Fixed Plus Current and Fixed Plus Budget. Under Fixed Plus Current, the customer's past due balance is divided by the number of months agreed to in the payment plan; the amount due is that monthly amount plus the current month's bill. Under Fixed Plus Budget, the customer's past due balance is divided into the agreed number of months (usually 12) and the fixed monthly amount is set based on the average of 12 months of usage.

Down payments without extenuating circumstances. A customer without extenuating circumstances will generally be offered the down payment amounts in the "Normal Payment Agreements" line of the Graduated Down Payment Structure table below, with the required down payment increasing if the customer has entered into and broken past payment arrangements in the most recent (rolling) 12 months. The Company will negotiate payment agreement terms, including down payment amounts and length of arrangements, individually with each customer. Based on their household financial circumstances, customers may be offered lower down payments than those shown in the Normal Payment Agreements line on a case-by-case basis. During the Cold Weather Rule months, customers with income at or below 50% of the state median will not pay a down payment exceeding 10% of their monthly income, consistent with https://www.revisor.mn.gov/statutes/cite/2168.096, Subd. 5.

Down payments for extenuating circumstances. The Company will negotiate payment agreement terms, including down payment amounts and length of arrangements, individually with each customer. Based on extenuating circumstances, customers may be offered lower down payments than those shown in the "Extenuating Circumstances Payment Agreement" line of the Graduated Down Payment Structure table below on a case-by-case basis. During the Cold Weather Rule months, customers with income at or below 50% of the state median will not pay a down payment exceeding 10% of their monthly income, consistent with https://www.revisor.mn.gov/statutes/cite/216B.096, Subd. 5.
