Hi Hanna,

Thanks for your thoughtful questions and for following up after the last reactive workgroup meeting.

At this point, we're still in the early stages of evaluating the internal systems that will be necessary to support both the reactive and proactive programs. We've established an internal team that is reviewing our existing software and processes to assess capabilities, identify any gaps, and determine the scope of any upgrades or new development that may be needed.

As part of that work, we're considering the extent to which our existing systems may be able to be adapted versus whether more significant development efforts might be required. The goal is to ensure we have a flexible and scalable approach that can accommodate the tracking and financial accounting needs of both the reactive and proactive implementations, even as those needs continue to take shape.

We'll continue to evaluate these questions as our internal work progresses. Please feel free to reach out if there's anything else we can help clarify.

A couple high level questions for you on the internal system development you mentioned at the last reactive workgroup meeting to do the various accounting and tracking for the reactive cost share program.

- 1. Are you anticipating that the system will be able to individually track the various accounting steps towards specific reactive upgrade projects within the program (mobilization funds, cost share fees, overpayments, cost share window length, etc)?
- 2. Would this same system be able to do similar tracking for individual proactive upgrade projects, understanding that there may be additional administrative costs to do so?
