Comments of the Minnesota Department of Commerce Division of Energy Resources

I. BACKGROUND

Owatonna Public Utilities is an electric municipal utility organized and existing under the laws of the State of Minnesota. Steele-Waseca Cooperative Electric is an electric distribution cooperative organized and existing under the laws of the State of Minnesota.

On March 25, 2019, the Minnesota Department of Commerce, Division of Energy Resources (Department) filed Comments in this docket. It was later discovered that the legal description for the Transfer Area was described by the Department contained typographical errors. Thus, the Department's March 27, 2019 Corrected Comments replace its March 25, 2019 Comments in this proceeding.

II. SUMMARY OF PROPOSAL

On February 25, 2019, Owatonna Public Utilities (the Municipal) and Steele-Waseca Cooperative Electric (the Cooperative), collectively the Parties, jointly filed a petition under Minnesota Statutes Sections 216B.39 and 216B.40, asking the Minnesota Public Utilities Commission (Commission) to modify the Parties' service territory boundaries. This joint request concerns the permanent transfer of six areas as described below, within the city limits of the Municipal and within the assigned service territory of the Cooperative.

Approval of the Parties' request would permanently transfer the Affected Areas that involve approximately 552 acres¹ and 90 customers (6 residential, 77 commercial, and 7 industrial) from the Cooperative to the Municipal.

¹ The Petitioner's March 13, 2019 Update notes the total acreage of the Transfer Area is approximately 552 acres, rather than the 569.67 acres noted in its original Petition.

III. DEPARTMENT ANALYSIS

A. TRANSFER OF THE AFFECTED AREA FROM THE COOPERATIVE TO THE MUNICIPAL

Revised Exhibit A to the Petition, as submitted on March 13, 2019, is a map that depicts the boundaries of the Transfer Areas. Revised Exhibit B to the Petition, as submitted on March 13, 2019, contains the legal description for the Transfer Areas as follows:

The six areas that comprise the Affected Areas are legally described as follows:

AREA 1

B. CUSTOMER NOTICE

Attached as Exhibit A to the Parties March 15, 2019 AFFIDAVIT, is a one-page Customer Notice Letter relating to the transfer of electric service territory from Steele-Waseca Cooperative Electric to Owatonna Public Utilities that was provided to customers in the Affected Area. The

Customer Notice identifies the pending proceeding before the Commission regarding the process of formally updating the service area maps to reflect the Municipal as the service provider to the Affected Area.

C. ANTICIPATED TRANSFER DATE

The Department notes that the Parties have agreed to transfer electric service on a mutually agreed upon date, anticipated to be in Summer 2019, per the March 13, 2019 Customer Notice Letter.

D. COMPENSATION

The Department notes that the Parties have agreed on appropriate compensation.

Thus, the Department agrees that the Parties' request to establish the Affected Areas as part of the Municipal's service area is consistent with Minnesota Statutes 216B.39 and 216B.40.

IV. RECOMMENDATION

The Department recommends that the Commission approve the requested service territory transfer from Steele-Waseca Cooperative Electric to Owatonna Public Utilities. MnGeo should update the Commission's maps to reflect the service area designations as shown on the revised map in the March 13, 2019 update. Please note that Shana Neumann is the primary MnGeo contact for the Commission's service area map updates.
