In accordance with Minn. R. 7850.2800, subp. 2, this letter serves as notice to the Minnesota Public Utilities Commission (“Commission”) that Dairyland Power Cooperative (“Dairyland”) intends to submit an Application for a High Voltage Transmission Line (“HVTL”) Route Permit for the Beaver Creek Transmission Line Project, a new 161-kilovolt HVTL and associated facilities to be located in Fillmore County, Minnesota, under the alternative permitting procedures of Minn. R. 7850.2800 to 7850.3900. Dairyland intends to submit the Route Permit Application to the Commission in the Third Quarter of 2024.
