Dakota Electric Association files this letter in response to the Minnesota Public Utilities Commission's ("Commission") April 23, 2020 Notice of Schedule for Filing Exceptions to the ALJ's Report and Request for Dakota Electric Association to File Schedules Reflecting the ALJ's Recommendation in the above-captioned docket. Dakota Electric Association provided the requested schedules on April 24, 2020. The Office of the Attorney General-Residential Utilities Division ("OAG") filed a letter on April 28, 2020, indicating it has no exceptions and clarifying one matter regarding inclusion of a true-up calculation in future AGi Rider filings by Dakota Electric Association. The Department of Commerce Division of Energy Resources ("Department") filed a letter on May 4, 2020 recommending that the Commission adopt the ALJ Report with a few minor corrections and clarifications.

Dakota Electric Association has also fully reviewed the Administrative Law Judge's Findings of Fact, Conclusions of Law and Recommendations ("Report") in this matter and takes no exception to Administrative Law Judge LaFave's Report. The Report reflects the record and the agreements reached by the parties during the course of this proceeding and agrees with the OAG comments regarding the AGi Rider and the Department's minor corrections and clarifications.
