Mr. Seuffert:

Energy Environmental Review and Analysis (EERA) staff reviewed the Findings of Fact, Conclusions of Law, and Recommendations issued by Administrative Law Judge (ALJ) Barbara J. Case for the Byron Solar 200 MW Solar Generating Facility and associated 345 kV High Voltage Transmission Line (HVTL) proposed by Byron Solar, LLC.

EERA appreciates the comprehensive analysis of the record and concurs with Judge Case's recommendation that the Public Utilities Commission (Commission) grant a site permit for the project and a route permit for the Blue Route. EERA staff has no exceptions to the ALJ report.

For the convenience of Commission, EERA staff is providing three attachments to be included with the site and route permits.

- **Attachment A** is a route map for inclusion with the route permit. The attached map shows only the blue route, as recommended in the ALJ report, not both the blue and red routes as shown in previous maps.
- **Attachment B** is a table summarizing the compliance filings required for the site permit with the conditions recommended by Judge Case. This table updates the compliance table included in the Draft Site Permit in Appendix C of the Environmental Assessment to include
 - a status report every six months if construction is delayed (Section 8.4);
 - specific information to be shown on the site plan (Section 8.3);
 - a separate Visual Screening Plan (Section 5.5); and
 - documentation of coordination with snowmobile trail re-routing (Section 5.6);

- **Attachment C** is a table summarizing the compliance filings required for the route permit. This table is unchanged from the compliance table included in the Draft Route Permit in Appendix D of the Environmental Assessment and is included here only for convenience.

EERA staff is available to answer any questions the Commission may have.


