PETITION FOR APPROVAL OF AN ELECTRIC CONSERVATION IMPROVEMENT PROGRAM ADJUSTMENT FACTOR DOCKET NO. E002/M-25-50

Dear Mr. Seuffert:

Northern States Power Company, doing business as Xcel Energy, submits to the Minnesota Public Utilities Commission these Reply Comments in response to Initial Comments submitted by the Department of Commerce, Division of Energy Resources (Department) on July 22, 2025.

In their comments, the Department recommended approval of Xcel Energy's:

- Shared Savings DSM financial incentive of \$15,133,727;
- Electric CIP Tracker Account, as filed on April 1, 2025, with an ending balance of (\$41,453,010);
- Proposed CIP Adjustment Factor of \$0.001396 per kWh; and
- Proposed bill message.

We thank the Department for their analysis and within this Reply provide an update to our adjustment factor based on actual data so that the Commission may approve the most up-to-date accounting information.

Updated Electric CIP Adjustment Factor

We provide as Attachment A, an update of the electric DSM Cost Recovery and Incentive Mechanism Tracker and Balance. The update includes actual spend and total recovery (through both the CIP Adjustment Factor and the Conservation Cost Recovery Charge) through June 2025. As a result of these adjustments, the

resulting factor has increased from our April 2025 Proposal from \$0.001396 per kilowatt-hour (kWh) to \$0.001397 per kilowatt-hour.

Updated Tariff Sheet

We provide as Attachment B to this filing, an updated compliance tariff sheet for our Electric Rate Book, in redline and clean format, to reflect this proposed change as follows:

Updated Customer Bill Message

The following bill message will alert our electric customers to the updated CIP Adjustment Factor:

Effective [TBD], the Resource Adjustment line item on your bill has been reduced due to a change in the Conservation Improvement Program (CIP) factor. The electric CIP portion of the Resource Adjustment is \$0.001397 per kilowatt-hour (kWh).

The effective date will depend upon the final date of the Commission Decision as we typically adjust the rate the month after receiving the written order.

As a result of these changes, the Company requests the Commission:

- Approve Xcel Energy's electric Shared Savings DSM financial incentive of \$15,133,727;
- Approve Xcel Energy's 2024 electric CIP Tracker Account, as filed on August 4, 2025, with an ending balance of (\$41,453,010);
- Approve Xcel Energy's proposed 2025-2026 electric CIP Adjustment Factor of \$0.001397 per kWh;
- Approve Xcel Energy's proposed bill message, effective the first month the \$0.001397 per kWh electric CIP Adjustment Factor takes effect, revised as necessary to incorporate the approved cost adjustment factor and effective date; and
- Require Xcel Energy to submit a compliance filing with tariff sheets and all necessary calculations within 10 days of the issue date of the Order.

APPLICABILITY

Applicable to bills for electric service provided under the Company's retail rate schedules. Exemptions are as follows:

"Large Customer Facility" customers that have been exempted from the Company's Conservation Improvement Program charges pursuant to Minn. The CIP Adjustment Factor shall be calculated for each customer class by dividing the Recoverable Conservation Improvement Program Expense by the Projected Retail Sales for a designated recovery period. The factor may be adjusted annually with approval of the Minnesota Public Utilities Commission. The CIP Adjustment Factor for all rate schedules is:

Recoverable Conservation Improvement Program Expense shall be the CIP expense not recovered through base rates as determined from the CIP Tracker account balance for a designated period. All costs appropriately charged to the CIP Tracker Account shall be eligible for recovery through this Rider. All revenues received from the CIP Adjustment Factor shall be credited to the CIP Tracker Account.

Recoverable Conservation Improvement Program Expense shall be the CIP expense not recovered through base rates as determined from the CIP Tracker account balance for a designated period. All costs appropriately charged to the CIP Tracker Account shall be eligible for recovery through this Rider. All revenues received from the CIP Adjustment Factor shall be credited to the CIP Tracker Account.

<u>Projected Retail Sales</u> shall be the estimated kilowatt-hour sales to all non-exempt customers for the designated recovery period.
