Dear Mr. Wolf:

Northern States Power Company, doing business as Xcel Energy, respectfully requests the Minnesota Public Utilities Commission extend the compliance filing date for final journal entries for the sale of land and tanks at our Wescott Plant from May 10, 2019 to August 15, 2019.

We completed our sale of the land and tanks located at our Wescott facility on April 10, 2019. Per Order Point 8 of the Commission's March 28, 2019 Order, a compliance filing containing the final journal entries from the transaction is required 30 days after the close of the sale. However, due to the complexity of the steps involved in this transaction, including the separation<sup>1</sup> of the LNG and LP facilities, there is still work being performed so we do not yet have final costs to incorporate into our journal entries. Accordingly, we request additional time to make this compliance filing.

We have electronically filed this document with the Minnesota Public Utilities Commission, and copies have been served on the parties on the attached service list. <sup>1</sup> Selling the LP facilities to Flint Hills required a number of modifications to fully separate the LNG facilities (which the Company still owns) from the LP facilities, so the two facilities—now owned by two unaffiliated entities—would have adequate security and infrastructure to communicate and measure service separately.
