The purpose of this letter is to provide information regarding an anticipated short-term change to Greater Minnesota Gas's transportation subscription during July, 2015. GMG was notified that Viking's mainline transportation will be disrupted in July to perform hydro-testing. Viking advised that the outage is planned to run from July 8, 2015 through July 22, 2015. However, any time a hydro-test is performed, uncertainty exists regarding whether an extended outage will be required for repairs.

To ensure firm supply, GMG intends to subscribe for 350 dekatherms of firm transport on Northern Natural to Chisago for the entire month of July. GMG anticipates this option will save customers \$336.00 when compared to purchasing interruptible transport on Northern.
