RE: Letter from the Minnesota Department of Commerce, Division of Energy Resources (the Department) regarding CenterPoint Energy Resources Corporation d/b/a CenterPoint Energy Minnesota Gas's (CPE or the Company) Petition for Approval of an Affiliated Interest Agreement between CenterPoint Energy Minnesota Gas and Minnesota Limited.

Dear Mr. Seuffert:

On December 30, 2019, the Minnesota Public Utilities Commission (Commission) issued its Order in the above-referenced docket approving CPE's construction services contract with Minnesota Limited, LLC, a non-regulated subsidiary of Vectren Corporation, which is a wholly-owned subsidiary of CenterPoint HoldCo (Order). The Order also required CPE to file the following information within 30 days of the Order:

- A. a description of any changes in CenterPoint Gas's relationship with Minnesota Limited, its affiliated vendor;
- B. detail of the actual costs of the scope of work described on pages 4-10 of the 2019 Affiliated Interest Agreement and a comparison of the actual cost of the work to the estimated cost of the work as reported in Exhibit D of the Petition, with an explanation of any significant differences;
- C. detail of any changes to the scope of work to be performed under the 2019 AIA (e.g. additions via change orders), including:
 - an explanation of what the changes are and why they were necessary;
 - the additional costs associated with the changes, and a demonstration that those additional costs are reasonable.

On January, 29, 2020, CPE filed the requested information in a compliance filing.

On February 5, 2020, CPE filed a letter announcing that it had entered into an agreement to sell Miller Pipeline and Minnesota Limited (collectively, MVerge) to PowerTeam Services, LLC. CPE's letter also contained a press release and Form 8-k that was filed with the Securities and Exchange Commission (SEC).

On February 20 2020, the Commission filed its *NOTICE OF REQUEST FOR INFORMATION AND SUBSEQUENT COMMENT PERIOD* (Notice). The Commission's Notice stated that CPE shall provide the following information by March 6, 2020:

 Preliminary, pro-forma journal entries that would record the sale of Miller Pipeline and Minnesota Limited (collectively, MVerge) to PowerTeam Services, LLC. Mr. William Seuffert April 10, 2020 Page 2

> A copy and explanation of any information (including SEC disclosure filings) provided to shareholders and other stakeholders related to the effects of this sale.

The Commission's Notice also established dates for initial comments by April 10, 2020 and reply comments by April 24, 2020.

In addition, the Commission's Notice stated that the following topics were open for discussion:

- Does this sale have an impact on Minnesota ratepayers? If so, how?
- Will this transaction result in any anticipated Goodwill impairment charges for CenterPoint Energy, Inc. (CNP)?
- What will CNP's pro-forma capital structure be following this sale?
- How will Minnesota ratepayers be protected from any possible credit rating agencies' downgrades that may result from this sale?
- Will this sale have an impact on rate base or O&M expenses in CPE's current rate case?
- How will this sale impact the 2020 construction season?
- Are there other issues or concerns related to this matter?

On March 6, 2020, CPE filed its preliminary pro-forma journal entries along with other information, such as press releases, employee announcements, and 4^{th} quarter earnings information, in accordance with the Commission's Notice.

The Department reviewed CPE's March 6, 2020 filing and notes that the information contained therein does not allow the Department to analyze and answer the topics open for discussion. For example, the information provided in CPE's March 6, 2020 filing does not include information regarding the impacts on CPE's rate case, goodwill, or capital structure. As a result, the Department will wait for CPE to provide this information in initial comments due April 10, 2020. If CPE does not file initial comments addressing these topics by April 10, 2020, the Department recommends that the Commission require CPE to make such a filing. Once this information is provided by CPE, the Department requests that the Commission allow the Department and other interested parties to file reply comments within 30 days of CPE's filing.

The Department is available to answer any questions that the Commission may have.
