## **Comments of the Minnesota Department of Commerce**

#### I. INTRODUCTION

In its February 4, 2025 filing Plum Creek states that it has experienced a number of delays preventing the start of construction of the Project within the required extended construction period and thus it will be unable to meet the in-service data as extended previously by the Commission.<sup>1</sup> Plum Creek stated that it expects that the in-service date of the Project to be delayed until December 31, 2028. The Company notes, however, that the Project is now exempt from Certificate of Need requirements and additionally has been selected by Xcel Energy in a competitive bidding process in an ongoing docket with the Commission.<sup>2</sup>

#### II. PROCEDURAL BACKGROUND

November 12, 2019 Plum Creek filed its *Application for Certificate of Need* for the proposed Plum Creek wind generating facility.<sup>3</sup>

September 23, 2021 The Commission issued its *Order Granting Certificate of Need and Issuing Site Permit and Route Permit* approving the Project.<sup>4</sup>

May 5, 2023	Plum Creek submitted a request for the Commission to extend the inservice date for the Project by 2 years to December 31, 2026. <sup>5</sup>
July 5, 2023	The Commission approved Plum Creek's request to extend the in-service date for the Project until December 31, 2026. <sup>6</sup>
February 4, 2025	Plum Creek filed its Second Extension Request with the Commission requesting to extend the in-service date for the Project until December 31, 2028.
February 12, 2025	The Commission issued a Notice of Comment Period requesting Comments from parties regarding Plum Creek's Second Extension Request. <sup>7</sup>

- Should the Commission approve Plum Creek's request to amend the Certificate of Need for the Plum Creek Project?
- Should the Commission approve Plum Creek's requests to amend the site permit for the Plum Creek Project?
- Should the Commission approve Plum Creek's request to amend the route permit for the Plum creek Wind Project?
- If the amendments are authorized, what additional conditions, if any, should the Commission impose?
- Are there other issues or concerns related to this matter?

#### III. DEPARTMENT ANALYSIS

In its February 4, 2025, filing Plum Creek states that it has experienced a number of delays preventing the start of construction of the Project by the current in-service deadline of December 31, 2026. Plum Creek stated that it expects that the in-service date of the Project to be delayed until as late as December 31, 2028. This delay is due to both delays in the Midcontinent Independent System Operator (MISO) process for interconnection approvals and due to regulatory approvals with the Commission required for the sale of Plum Creek or its energy. Specifically, Plum Creek has been selected by Xcel Energy in its Xcel Settlement Agreement as a project that Xcel proposes to either purchase or purchase the output of.<sup>8</sup> The Settlement Agreement has been approved by the Commission, although the order has yet to be issued, and construction cannot occur prior to approval or before the Project finds another purchaser. Plum Creek states that these delays make it unlikely for the Project to begin construction until the summer of 2026 or the summer of 2027. Finally, the Company notes that under current statues, the Project would not be exempt from the Certificate of Need requirements, however the Company submitted this extension request as the Certificate of Need was granted prior to the change in statues and rules regarding wind faculties.

According to Minnesota Rules 7849.0400, subp. 2A "a delay of one year or less in the in-service date of a large generation or transmission facility previously certified by the Commission is not subject to review by the Commission." However, if a delay beyond one year from the approved in-service date is projected to occur, Minnesota Rules 7849.0400, subp. 2H requires the applicant to inform the Commission of the desired change and detail the reasons for the change, and the Commission shall order further hearings if it determines that the change, if known at the time of the need decision, could have resulted in a different decision under the criteria specified in Minnesota Rules 7849.0120.9

Regarding the criteria specified in Minnesota Rules 7849.0120,<sup>10</sup> Plum Creek states that demand for Wind facilities has only increased due to the passage of Minnesota Carbon Free-Standards. The original CN was approved with the note that the timing was taking advantage of federal tax incentives;<sup>11</sup> however, those incentives were extended as part of the Inflation Reduction Act of 2022<sup>12</sup> and thus a delay in timing will not change the availability of tax credits.

The Department reviewed the Applicant's proposal and concludes that the impact of the delay would only affect the timing analysis of the project, and that the extension of federal tax incentives mitigates any potential for the different in-service date to have affected the original Commission decision. Further, the Department notes that if the decision would have been being made now, rather than in the Commission's September 23, 2021 Order, the likely need for the Project would be higher due to the increase in the Renewable Energy Standard implemented by the Minnesota Legislature in February 2023. Finally, the Department notes that the Project's selection in a competitive bidding process
