On March 3, 2025, Minnesota Power (or the "Company") filed its 2025-2039 Integrated Resource Plan ("IRP") for Minnesota Public Utilities Commission (or the "Commission") approval. The Company submitted the core plan evaluation with its March 3rd filing and indicated that supporting appendices would be filed by the end of the month.
