UTILITY COMMENTS

Dear Mr. Seuffert,

Minnesota Power (or, the "Company") appreciates the extension granted for Utility Comments and respectfully submits the following in response to the Minnesota Public Utilities Commission's (or, "Commission") August 2, 2024 Notice of Comment Period pertaining to the surcharges funding the newly created Interconnection Ombudsperson position.

Tariff Language and Company Fee Tracking

Otter Tail Power's August 12 comments noted that documentation of Interconnection Application fees are already published and described in the Minnesota Distributed Energy Resources Interconnection Process (or, "MNDIP"). The Company does not currently define interconnection fees on its website for this reason, and recommends that the Ombudsperson Fee should be included with the fees listed in section 1.5.1 of MNDIP.

Process for Reporting, Tracking, and Adjusting Surcharges

The Company began collecting the omsbudperson fee for interconnection applications submitted to Minnesota Power starting on June 3. When an interconnection application is received, Minnesota Power creates a billable charge within its customer information system. A work order has been established and will be used to track those fees and payments to the Commission. The Company will remit payment according to the Commission's instructions by the 15th of each month.

Cadence and Review

The Company is open to an annual or biannual cadence to review the surcharge and recommends that this cadence be established after the Ombudsperson position is filled and its costs are more clearly understood. The Company also recommends that the Commission plan for fluctuations in the interconnection market by establishing a financial "buffer" for the position.
