RE: COMMENTS
2021 TRUE-UP MECHANISMS AND RATE CASE STAY OUT
DOCKET NOS. E002/M-20-743 AND E002/GR-20-723

Dear Mr. Seuffert:

Northern States Power Company, doing business as Xcel Energy, submits these Comments pursuant to the Minnesota Public Utilities Commission's *Notice of Comment Period* issued April 2, 2021 in the above-noted dockets.

The Commission issued its ORDER APPROVING TRUE-UPS WITH MODIFICATIONS AND REQUIRING XCEL TO WITHDRAW ITS NOTICE OF CHANGE IN RATES AND INTERIM RATE PETITION on April 2, 2021 (Order). Parties are asked to comment on whether the Commission should reconsider its approval of the Company's 2021 True-Up proposal¹ and withdrawal of its 2020 electric rate case application² in consideration of the Company's March 3, 2021 letter identifying a \$43 million overstatement of the Company's revenue requirement and requested interim rates. We appreciate this opportunity to offer additional perspective.

The Commission's Order approved the Company's 2021 True-Up proposal with modifications because it offered "the broadest protection to ratepayers as a whole and will ensure just and reasonable rates." The Commission determined this was the case because "[a]voiding an immediate interim rate increase" for all customer classes,

“reduces the risk of additional economic hardship and service disconnections to individuals, families, and businesses already experiencing financial strain as a result of the pandemic.” None of this is impacted by the error identified in the Company’s March 3, 2021 letter.

Similarly, none of the “substantial mitigation measures” offered by the Company “to reduce the impacts associated with [the] Stay Out Proposal” have changed. Assuming the Commission does not rescind its Order, the Company will (1) withdraw its request for deferral of any pandemic-related costs, including bad debt costs; (2) pay the full \$17.5 million of bill credits approved by the Commission in connection with the residential payment plan credit program; (3) implement the sales true-up for the Demand class over 21 months (rather than 12 months) beginning April 2022; and (4) apply an earnings cap to the Company’s Minnesota jurisdictional earnings for 2021 at 9.06 percent return on equity (ROE).

As discussed in the Company’s March 3, 2021 letter, when the Commission considered the Company’s Stay Out Proposal, it compared the proposal to the Company’s interim rate request of \$308.9 million, with rates in effect January 1, 2021. When accounting for the \$43 million overstatement, this interim rate request should have been \$265.7 million. Even with this change, however, the Stay Out Proposal would have compared favorably. The estimated sales true up was approximately \$171.1 million beginning in April 2022 (with rates flat in 2021), and the approved proposal included the additional mitigation measures listed above. Moreover, since this matter was initially considered by the Commission, we have updated our sales true-up forecast, and now project a total true up of approximately \$135.3 million, with reductions for nearly all customer classes, as shown below in Table 1. Because the Stay Out Proposal remains the best option for our customers, we believe reconsideration of the Order is not warranted.
