Enbridge Solar (Plummer), LLC (Plummer Solar), an independent power producer and wholly-owned subsidiary of Enbridge Holdings (Green Energy) L.L.C., is proposing to construct and operate an up to 130 megawatt (MW) alternating current photovoltaic solar energy generating facility and associated facilities known as the Plummer Solar Project in Red Lake County, Minnesota (Project). Plummer Solar respectfully submits this Site Permit Application (Application) to the Minnesota Public Utilities Commission (Commission) pursuant to the alternative permitting procedures of Minn. R. parts 7850.2800 to 7850.3900.

Enclosed for filing please find Plummer Solar's Application for a Site Permit for the Plummer Solar Project in Red Lake County, Minnesota, with public Appendices A-L, and NONPUBLIC Appendices F and K.

In accordance with Minnesota Rules, part 7829.0500, and Minnesota Statutes Chapter 13, Plummer Solar has designated portions of Appendix F as **NONPUBLIC DATA–NOT FOR PUBLIC DISCLOSURE** because it contains commercially-sensitive information regarding Plummer Solar's total installed capital costs and annual operating costs which, if released, would have a detrimental effect on Plummer Solar by providing potential competitors and others in the energy marketplace with valuable information not otherwise readily ascertainable and from which these persons would obtain economic value. Plummer Solar takes measures to ensure this information is not released publicly, including securing the data and entering into confidentiality agreements, as necessary, if the information is provided to another party. Given the need to include nonpublic information, Plummer Solar has prepared and is electronically filing both **NONPUBLIC** and public versions of Appendix F.

In accordance with Minnesota Rules, part 7829.0500, and Minnesota Statutes Chapter 13, Plummer Solar has designated portions of Appendix K as **NONPUBLIC DATA–NOT FOR PUBLIC DISCLOSURE** because it contains sensitive cultural resource and natural heritage

information. The Minnesota State Historic Preservation Office Manual for Archaeological Projects in Minnesota provides for restricted access to sensitive cultural resource information. Similarly, the natural heritage information is nonpublic under Minnesota Statutes § 84.0872. Given the need to include nonpublic information, Plummer Solar has prepared and is electronically filing both **NONPUBLIC** and public versions of Appendix K.

The Application filing fee was previously sent under separate cover. Plummer Solar is also providing copies of the Application as directed by staff as follows: two (2) copies to the Minnesota Department of Commerce, Energy Environmental Review and Analysis staff, and three (3) copies and one (1) jump drive to the Commission staff.
