Dear Ms. Agnew:

Birch Coulee Solar LLC (Birch Coulee Solar) submits these comments in response to comments submitted during the scoping comment period in the above-captioned matter, which closed on October 25, 2024.

During the October 9-10, 2024, scoping meetings, members of the public provided comments regarding vegetation management, screening, property values, and similar topics. Birch Coulee Solar does not object to their inclusion within the scope of the environmental assessment (EA) that the Department of Commerce, Energy Environmental Review and Analysis (EERA) will prepare for the Birch Coulee Solar Project (Project).

Written comments were submitted by Minnesota Department of Natural Resources (MDNR), Minnesota Department of Transportation (MnDOT), Operating Engineers Local 49 and North Central States Regional Council of Carpenters (Local 49), LIUNA Minnesota and North Dakota (LIUNA), Renville County, and members of the public.

MDNR requested that the EA include analysis of the following topics: security fencing; dust; lighting; bats, and wildlife-friendly erosion control. Birch Coulee Solar does not object to these topics being analyzed in the EA and looks forward to further coordination with MDNR regarding the Project.

MnDOT requested that the EA include analysis of Project access, protected species, and blowing snow control. Birch Coulee Solar likewise does not object to these topics being analyzed in the EA and will coordinate with MnDOT further regarding this Project, particularly with respect to Project access. Regarding MnDOT's comments on blowing snow control, Birch Coulee Solar notes that the Project area does not include the parcel outlined in blue in MnDOT's comments. Thus, Birch Coulee Solar does not currently anticipate that the Project will result in vegetation removal or alteration on this parcel.

Local 49 and LIUNA provided comments requested that the EA include analysis of the economic benefits of the Project and, particularly, potential benefits to local labor. Birch Coulee Solar also does not object to these topics being studied in the EA.

Birch Coulee Solar also provides further detail regarding the potential use of local labor for the Project in these comments. Specifically, Birch Coulee Solar anticipates issuing a Request for Proposal to an Engineering, Procurement and Construction (EPC) contractor to construct the Project. Birch Coulee Solar will include preferences for contractor bids that utilize local construction craft employees while being consistent with the Project's budget, timeline, industry standards and requirements, and corporate safety policies. The selected EPC contractor will work with labor unions, local subcontractors, or other vendors to implement a Project construction staffing model that attempts to maximize local hiring and local economic benefits for the Project to the extent practicable, while ensuring the Project is safely built on time and on budget.⁷

Renville County provided comments, filed on November 1, 2024, noting that the Project generally complies with County setbacks and requesting that the Commission consider certain permit conditions / requirements related to the Project. Birch Coulee Solar appreciates Renville County's engagement regarding the Project and does not object to the EA considering the topics identified by Renville County. Birch Coulee Solar looks forward to continued coordination with Renville County as the Project proceeds.

Members of the public submitted written comments, filed on November 1, 2024, generally expressing support for the Project, as well as identifying certain topics for inclusion in the EA,

including wetland analysis. Wetlands were addressed in Birch Coulee Solar's application, and Birch Coulee Solar likewise anticipates that potential wetland impacts will be analyzed in the EA.
