
Dear Dr. Haar:

I am writing on behalf of ITC Midwest, LLC ("ITC Midwest") as part of ITC Midwest's continuing effort to keep the Commission informed regarding the status of the construction of the Salem-Hazleton Project. As reflected in ITC Midwest's previous filings, unanticipated delays in acquiring rights-of-way was one of the impediments to timely completion of the Project. Accordingly, ITC Midwest is pleased to report that last month it completed acquisition of all rights-of-way necessary for completing of the Project. ITC Midwest continues to expect that the Salem-Hazleton 365kV transmission line will be in service by mid-2013.

As required by the Commission's May 15, 2012, Order Requiring Filings, ITC Midwest will be filing its next status report on or before December 31, 2012, and continue to report on the status every six months thereafter until the Project is complete.

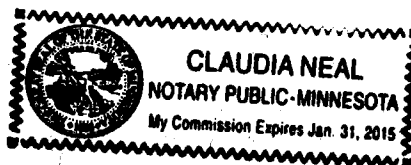
