We would also request that if there are any changes to methods, operations, procedures, configuration, routing, service area or other significant alterations described in the 911 plan, the telecommunication service provider should be required to submit an amendment of the 911 plan to the Public Utilities Commission and DPS-ECN. The Department of Public Safety, Minnesota 911 Program, requests at a minimum, an update to the 911 plan must be made on an annual basis, no later than June 1 of each year.
